## A BILL

To designate a portion of the United States courthouse lo-  
cated at 2100 Jamieson Avenue, in Alexandria, Virginia,  
as the “Justin W. Williams United States Attorney’s  
Building”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

**1 SECTION 1. DESIGNATION.**

2 (a) IN GENERAL.—The building and structure de-  
3 scribed in subsection (b) shall be known and designated  
4 as the “Justin W. Williams United States Attorney’s  
5 Building”.

6 (b) DESCRIPTION.—The building and structure to be  
7 designated under subsection (a) is that portion of the  
8 United States courthouse located at 2100 Jamieson Ave-  
9 nue, in Alexandria, Virginia (known as the Albert V.  
10 Bryan United States Courthouse), that is attached to the  
11 courthouse main tower structure, described as A-Wing in  
12 the architectural plans, and currently occupied by the Of-  
13 fice of the United States Attorney for the Eastern District  
14 of Virginia, Alexandria Division.

**15 SEC. 2. REFERENCES.**

16 Any reference in a law, map, regulation, document,  
17 paper, or other record of the United States to the building  
18 and structure described in section 1(b) shall be deemed  
19 to be a reference to the “Justin W. Williams United States  
20 Attorney’s Building”.

**21 SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

22 There are authorized to be appropriated such sums  
23 as may be necessary for appropriate identifying designa-  
24 tions to be affixed to the building and structure described  
25 in section 1(b) and for an appropriate plaque reflecting  
26 the designation and honoring Justin W. Williams and his

- 1 service to the Nation to be affixed to or displayed in such
- 2 building and structure.
