AN ACT

To authorize the Secretary of the Interior to conduct a study of the San Gabriel River Watershed, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “San Gabriel River Wa-
5 tershed Study Act”.

1 **SEC. 2. STUDY OF SAN GABRIEL RIVER WATERSHED.**

2 (a) IN GENERAL.—The Secretary of the Interior
3 (hereafter in this Act referred to as the “Secretary”) shall
4 conduct a special resource study of the following areas:

5 (1) The San Gabriel River and its tributaries
6 north of and including the city of Santa Fe Springs.

7 (2) The San Gabriel Mountains within the ter-
8 ritory of the San Gabriel and Lower Los Angeles
9 Rivers and Mountains Conservancy (as defined in
10 section 32603(c)(1)(C) of the State of California
11 Public Resource Code).

12 (b) STUDY CONDUCT AND COMPLETION.—Section
13 8(c) of Public Law 91–383 (16 U.S.C. 1a–5(c)) shall
14 apply to the conduct and completion of the study con-
15 ducted under this section.

16 (c) CONSULTATION WITH FEDERAL, STATE, AND
17 LOCAL GOVERNMENTS.—In conducting the study under
18 this section, the Secretary shall consult with the San Ga-
19 briel and Lower Los Angeles Rivers and Mountains Con-
20 servancy and other appropriate Federal, State, and local
21 governmental entities.

22 (d) CONSIDERATIONS.—In conducting the study
23 under this section, the Secretary shall consider regional
24 flood control and drainage needs and publicly owned infra-
25 structure such as wastewater treatment facilities.

1 **SEC. 3. REPORT.**

2 Not later than 3 years after funds are made available
3 for this Act, the Secretary shall submit to the Committee
4 on Energy and Natural Resources of the Senate and the
5 Committee on Resources of the House of Representatives
6 a report on the findings, conclusions, and recommenda-
7 tions of the study.

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “San Gabriel River Wa-
3 tershed Study Act”.

4 **SEC. 2. STUDY OF SAN GABRIEL RIVER WATERSHED.**

25 (d) CONSIDERATIONS.—In conducting the study
26 under this section, the Secretary shall consider regional

3 **SEC. 3. REPORT.**

4 Not later than 3 years after funds are made available
5 for this Act, the Secretary shall submit to the Committee

7 Committee on Resources of the House of Representatives
8 a report on the findings, conclusions, and recommenda-
9 tions of the study.
