## AN ACT

For the relief of Esidronio Arreola-Saucedo, Maria Elena Cobian Arreola, Nayely Bibiana Arreola, and Cindy Jael Arreola.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PERMANENT RESIDENT STATUS FOR**  
2 **ESIDRONIO ARREOLA-SAUCEDO, MARIA**  
3 **ELENA COBIAN ARREOLA, NAYELY BIBIANA**  
4 **ARREOLA, AND CINDY Jael ARREOLA.**

5 (a) IN GENERAL.—Notwithstanding subsections (a)  
6 and (b) of section 201 of the Immigration and Nationality  
7 Act, Esidronio Arreola-Saucedo, Maria Elena Cobian  
8 Arreola, Nayely Bibiana Arreola, and Cindy Jael Arreola  
9 shall be eligible for the issuance of immigrant visas or for  
10 adjustment of status to that of aliens lawfully admitted  
11 for permanent residence upon filing an application for  
12 issuance of immigrant visas under section 204 of that Act  
13 or for adjustment of status to lawful permanent resident.

14 (b) ADJUSTMENT OF STATUS.—If Esidronio Arreola-  
15 Saucedo, Maria Elena Cobian Arreola, Nayely Bibiana  
16 Arreola, and Cindy Jael Arreola enter the United States  
17 before the filing deadline specified in subsection (c),  
18 Esidronio Arreola-Saucedo, Maria Elena Cobian Arreola,  
19 Nayely Bibiana Arreola, and Cindy Jael Arreola shall be  
20 considered to have entered and remained lawfully and  
21 shall be eligible for adjustment of status under section 245  
22 of the Immigration and Nationality Act as of the date of  
23 enactment of this Act.

24 (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
25 FEES.—Subsections (a) and (b) shall apply only if the ap-  
26 plication for issuance of immigrant visas or the application

1 for adjustment of status are filed with appropriate fees  
2 within 2 years after the date of enactment of this Act.

3 (d) REDUCTION OF IMMIGRANT VISA NUMBERS.—

4 Upon the granting of immigrant visas or permanent resi-  
5 dence to Esidronio Arreola-Saucedo, Maria Elena Cobian  
6 Arreola, Nayely Bibiana Arreola, and Cindy Jael Arreola,  
7 the Secretary of State shall instruct the proper officer to  
8 reduce by 4, during the current or next following fiscal  
9 year, the total number of immigrant visas that are made  
10 available to natives of the country of the aliens' birth  
11 under section 203(a) of the Immigration and Nationality  
12 Act or, if applicable, the total number of immigrant visas  
13 that are made available to natives of the country of the  
14 aliens' birth under section 202(e) of that Act.
