AN ACT

To designate Catoctin Mountain Park in the State of Maryland as the “Catoctin Mountain National Recreation Area”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Catoctin Mountain Na-
5 tional Recreation Area Designation Act”.

1 **SEC. 2. CATOCTIN MOUNTAIN NATIONAL RECREATION**
2 **AREA.**

3 (a) DESIGNATION.—Catoctin Mountain Park in the
4 State of Maryland is designated as the Catoctin Mountain
5 National Recreation Area.

6 (b) REFERENCES.—Any reference in a law, map, reg-
7 ulation, document, paper, or other record of the United
8 States to Catoctin Mountain Park shall be deemed to be
9 a reference to the Catoctin Mountain National Recreation
10 Area (hereinafter referred to as the “recreation area”).

11 (c) BOUNDARY.—

12 (1) IN GENERAL.—The recreation area shall
13 consist of land within the boundary depicted on map
14 entitled “Catoctin Mountain National Recreation
15 Area” numbered 841/80444A, and dated March 7,
16 2003.

17 (2) AVAILABILITY OF MAP.—The map shall be
18 on file and available for public inspection in the ap-
19 propriate offices of the National Park Service.

20 (3) MINOR BOUNDARY ADJUSTMENTS.—The
21 Secretary of the Interior may make minor adjust-
22 ments in the boundary of the recreation area con-
23 sistent with section 7(c) of the Land and Water
24 Conservation Fund Act of 1965 (16 U.S.C. 4601–
25 9(c)).

26 (d) ADMINISTRATION.—

1 (1) IN GENERAL.—The Secretary of the Inte-
2 rior shall administer the recreation area in a manner
3 that protects and enhances the scenic, natural, cul-
4 tural, historical, and recreational resources of the
5 recreation area, in accordance with this Act and the
6 laws generally applicable to units of the National
7 Park System, including the Act of August 25, 1916
8 (16 U.S.C. 1, 2–4) and the Act of August 21, 1935
9 (16 U.S.C. 461 et seq.).”

10 (2) COOPERATIVE AGREEMENT.—The Secretary
11 of the Interior shall enter into a cooperative agree-
12 ment with the Secretary of the Navy for the oper-
13 ation of the presidential retreat, known as Camp
14 David, while preserving the site as part of the na-
15 tional recreation area. Nothing done under this Act
16 shall conflict with the administration of the presi-
17 dential retreat as a residence for the President and
18 his family and for his official purposes, nor shall it
19 alter any privileges, powers, or duties vested in the
20 White House Police and the United States Secret
21 Service, Treasury Department, by section 202 of
22 title 3, United States Code, and section 3056 of title
23 18, United States Code.

1 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

2 There are authorized to be appropriated such sums
3 as may be necessary to carry out this Act.
