A BILL

To award a congressional gold medal to Prime Minister
Tony Blair.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDING.**

4 Congress finds that Prime Minister Tony Blair of the
5 United Kingdom has clearly demonstrated, during a very
6 trying and historic time for our 2 countries, that he is
7 a staunch and steadfast ally of the United States of Amer-
8 ica.

9 **SEC. 2. CONGRESSIONAL GOLD MEDAL.**

10 (a) PRESENTATION AUTHORIZED.—The Speaker of
11 the House of Representatives and the President Pro Tem-
12 pore of the Senate shall make appropriate arrangements
13 for the presentation, on behalf of Congress, of a gold
14 medal of appropriate design, to Prime Minister Tony
15 Blair, in recognition of his outstanding and enduring con-
16 tributions to maintaining the security of all freedom-loving
17 nations.

18 (b) DESIGN AND STRIKING.—For purposes of the
19 presentation referred to in subsection (a), the Secretary
20 of the Treasury (referred to in this Act as the “Sec-
21 retary”) shall strike a gold medal with suitable emblems,

1 devices, and inscriptions to be determined by the Sec-
2 retary.

3 **SEC. 3. DUPLICATE MEDALS.**

4 The Secretary may strike and sell duplicates in
5 bronze of the gold medal struck pursuant to section 2
6 under such regulations as the Secretary may prescribe, at
7 a price sufficient to cover the cost thereof, including labor,
8 materials, dies, use of machinery, and overhead expenses,
9 and the cost of the gold medal.

10 **SEC. 4. STATUS OF MEDALS.**

11 (a) NATIONAL MEDALS.—The medals struck pursu-
12 ant to this Act are national medals for purposes of chapter
13 51 of title 31, United States Code.

14 (b) NUMISMATIC ITEMS.—For purposes of section
15 5134 of title 31, United States Code, all medals struck
16 under this Act shall be considered to be numismatic items.

17 **SEC. 5. AUTHORITY TO USE FUND AMOUNTS; PROCEEDS OF**
18 **SALE.**

19 (a) AUTHORITY TO USE FUND AMOUNTS.—There is
20 authorized to be charged against the United States Mint
21 Public Enterprise Fund such amounts as may be nec-
22 essary to pay for the costs of the medals struck pursuant
23 to this Act.

24 (b) PROCEEDS OF SALE.—Amounts received from the
25 sale of duplicate bronze medals authorized under section

- 1 3 shall be deposited into the United States Mint Public
- 2 Enterprise Fund.
