## A BILL

To require that the recommended national protocol for sexual assault medical forensic examinations include a recommendation that rape victims be offered information about emergency contraceptives to prevent pregnancy.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Best Help for Rape  
3 Victims Act”.

4 **SEC. 2. REQUIRED ELEMENT OF NATIONAL PROTOCOL FOR**  
5 **SEXUAL ASSAULT MEDICAL FORENSIC EX-**  
6 **AMINATIONS.**

7 (a) IN GENERAL.—Section 1405 of the Violence  
8 Against Women Act of 2000 (42 U.S.C. 3796gg note) is  
9 amended—

10 (1) by redesignating subsection (d) as sub-  
11 section (e); and

12 (2) by inserting after subsection (c) the fol-  
13 lowing new subsection:

14 “(d) REQUIRED ELEMENT OF PROTOCOL.—The na-  
15 tional protocol required by subsection (a)(3) shall include  
16 a recommendation to the effect that a victim of sexual as-  
17 sault who is at risk of pregnancy from rape—

18 “(1) should be offered information about emer-  
19 gency contraception; and

20 “(2) should, if the victim so requests, be pro-  
21 vided with emergency contraception on site.”.

22 (b) IMPLEMENTATION TO PROTOCOL ALREADY  
23 ISSUED.—The Attorney General shall ensure that any  
24 protocol already issued under section 1405(a)(3) of the Vi-  
25 olence Against Women Act of 2000 is, not later than 30  
26 days after the date of the enactment of this Act, revised

1 and reissued in a form that complies with section 1405(d)  
2 of that Act (as added by subsection (a)(2) of this section).
