**A BILL**

To authorize appropriations for the National Fish and  
Wildlife Foundation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “National Fish and Wild-*  
3 *life Foundation Reauthorization Act of 2005”.*

4 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

5 *Section 10(a)(1) of the National Fish and Wildlife*  
6 *Foundation Establishment Act (16 U.S.C. 3709(a)(1)) is*  
7 *amended by striking “fiscal years 2001 through 2005” and*  
8 *inserting “fiscal years 2006 through 2010”.*

9 **SEC. 3. APPLICATION OF NOTICE REQUIREMENT LIMITED**  
10 **TO GRANTS MADE WITH FEDERAL FUNDS.**

11 *Section 4(i) of the National Fish and Wildlife Founda-*  
12 *tion Establishment Act (16 U.S.C. 3703(i)) is amended by*  
13 *striking “grant of funds” and inserting “grant of Federal*  
14 *funds in an amount greater than \$10,000”.*

15 **SEC. 4. CLARIFICATION OF AUTHORITY TO USE FEDERAL**  
16 **FUNDS TO MATCH CONTRIBUTIONS MADE TO**  
17 **RECIPIENTS OF NATIONAL FISH AND WILD-**  
18 **LIFE FOUNDATION GRANTS.**

19 *Section 10(a)(3) of the National Fish and Wildlife*  
20 *Foundation Establishment Act (16 U.S.C. 3709(a)(3)) is*  
21 *amended by inserting “, or to a recipient of a grant pro-*  
22 *vided by the Foundation,” after “made to the Foundation”.*

23 **SEC. 5. REPEAL.**

24 *Effective September 30, 2015, the National Fish and*  
25 *Wildlife Foundation Establishment Act (16 U.S.C. 3701 et*  
26 *seq.) is hereby repealed.*
