1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FORMULATIONS OF PINOXADEN/**
4 **CLOQUINTOCET-MEXYL.**

5 (a) CALENDAR YEARS 2006 AND 2007.—

6 (1) IN GENERAL.—Subchapter II of chapter 99
7 of the Harmonized Tariff Schedule of the United
8 States is amended by inserting in numerical se-
9 quence the following new heading:

1 (2) EFFECTIVE DATE.—The amendment made
2 by paragraph (1) applies to goods entered, or with-
3 drawn from warehouse for consumption, on or after
4 the 15th day after the date of enactment of this Act.

5 (b) CALENDAR YEAR 2008.—

6 (1) IN GENERAL.—Heading 9902.90.17 of the
7 Harmonized Tariff Schedule of the United States, as
8 added by subsection (a), is further amended—

9 (A) by striking “Free” and inserting
10 “1.74%”; and

11 (B) by striking “On or before 12/31/2007”
12 and inserting “On or before 12/31/2008”.

13 (2) EFFECTIVE DATE.—The amendments made
14 by paragraph (1) shall take effect on January 1,
15 2008.
