AN ACT

To adjust the boundary of the Minidoka Internment National Monument to include the Nidoto Nai Yoni Memorial in Bainbridge Island, Washington, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Bainbridge Island Jap-
3 anese American Monument Act of 2007”.

4 **SEC. 2. BOUNDARY ADJUSTMENT.**

5 (a) IN GENERAL.—The boundary of the Minidoka In-
6 ternment National Monument, located in the State of
7 Idaho and established by Presidential Proclamation 7395
8 of January 17, 2001, is adjusted to include the Nidoto
9 Nai Yoni (“Let it not happen again”) memorial. That me-
10 morial—

11 (1) commemorates the Japanese Americans of
12 Bainbridge Island, Washington, who were the first
13 to be forcibly removed from their homes and relo-
14 cated to internment camps during World War II
15 under Executive Order No. 9066; and

16 (2) consists of approximately 8 acres of land
17 owned by the City of Bainbridge Island, Wash-
18 ington, as depicted on the map titled “Bainbridge
19 Island Japanese American Memorial”, numbered
20 194/80,003, and dated September, 2006.

21 (b) MAP.—The map referred to in subsection (a)
22 shall be kept on file and made available for public inspec-
23 tion in the appropriate offices of the National Parks Serv-
24 ice.

1 **SEC. 3. ADMINISTRATION OF MONUMENT.**

2 (a) ADMINISTRATION.—The Secretary of the Interior
3 (hereinafter in this section referred to as the “Secretary”)
4 shall administer the Nidoto Nai Yoni Memorial as part
5 of Minidoka Internment National Monument in accord-
6 ance with—

7 (1) Presidential Proclamation 7395 of January
8 17, 2001;

9 (2) laws and regulations generally applicable to
10 units of the National Park System, including the Act
11 of August 25, 1916 (popularly known as the “Na-
12 tional Park Service Organic Act,”; 16 U.S.C. 1 et
13 seq); and

14 (3) any agreements entered into pursuant to
15 subsection (b).

16 (b) AGREEMENTS.—

17 (1) For the purposes of defining the role of the
18 National Park Service in administering the Nidoto
19 Nai Yoni Memorial owned by the City of Bainbridge
20 Island, the Secretary is authorized to enter into
21 agreements with—

22 (A) the City of Bainbridge Island;

23 (B) the Bainbridge Island Metropolitan
24 Park and Recreational District;

25 (C) the Bainbridge Island Japanese Amer-
26 ican Community Memorial Committee;

1 (D) the Bainbridge Island Historical Soci-
2 ety;

3 (E) successor entities to the entities named
4 in subparagraphs (A) through (D); and

5 (F) other appropriate individuals or enti-
6 ties, at the discretion of the Secretary.

7 (2) In order to implement an agreement pro-
8 vided for in paragraph (1), the Secretary may—

9 (A) make grants to the City of Bainbridge
10 Island for development of an administrative and
11 interpretive facility for the Nidoto Nai Yoni Me-
12 morial;

13 (B) enter into a cooperative management
14 agreement with the City of Bainbridge Island,
15 pursuant to section 3(l) of Public Law 91–383
16 (16 U.S.C. 1a–2(l); popularly known as the
17 “National Park System General Authorities
18 Act”), for the purpose of providing assistance
19 with operation and maintenance of the memo-
20 rial;

21 (C) make grants to other non-Federal enti-
22 ties for other infrastructure projects at the me-
23 morial, subject to a match of non-Federal fund-
24 ing equal to the amount of a grant made pursu-
25 ant to this paragraph; and

1 (D) make grants or enter into cooperative
2 agreements with non-Federal entities to support
3 development of interpretive media for the me-
4 morial.

5 (c) ADMINISTRATIVE AND VISITOR USE SITE.—The
6 Secretary is authorized to operate and maintain a site in
7 Seattle, Washington, for administrative and visitor use
8 purposes associated with Minidoka Internment National
9 Monument, using to the greatest extent practicable the fa-
10 cilities and other services of the Seattle unit of the Klon-
11 dike Gold Rush National Historical Park.

12 (d) COORDINATION OF INTERPRETIVE AND EDU-
13 CATIONAL MATERIALS AND PROGRAMS.—The Secretary
14 shall coordinate the development of interpretive and edu-
15 cational materials and programs for the Nidoto Nai Yoni
16 Memorial and the Minidoka Internment National Monu-
17 ment site in the State of Idaho with the Manzanar Na-
18 tional Historic Site in the State of California.
