A BILL

To establish the Office of the Capitol Visitor Center within the Office of the Architect of the Capitol, headed by the Chief Executive Officer for Visitor Services, to provide for the effective management and administration of the Capitol Visitor Center, and for other purposes.

 2 **MANAGEMENT OF CAPITOL**
 3 **VISITOR CENTER**

4 **Subtitle A—Description of Facility**

5 **SEC. 101. DESCRIPTION AND PURPOSES OF CAPITOL VIS-**
 6 **ITOR CENTER.**

7 (a) *TREATMENT AS PART OF CAPITOL.*—*In this Act,*
 8 *the “Capitol Visitor Center” is the facility authorized for*
 9 *construction under the heading “Capitol Visitor Center”*
 10 *under chapter 5 of title II of division B of the Omnibus*
 11 *Consolidated and Emergency Supplemental Appropriations*
 12 *Act, 1999 (Public Law 105–277; 112 Stat. 2681–569), and*
 13 *such facility shall be considered to be part of the United*
 14 *States Capitol for all provisions of law in accordance with*
 15 *this Act.*

16 (b) *PURPOSES OF THE FACILITY.*—*In accordance with*
 17 *the provisions of this Act, the Capitol Visitor Center shall*
 18 *be used to—*

1 *Legislative Branch Appropriations Act, 2002 (Public Law*
2 *107–68; 115 Stat. 588)*—

3 (1) *shall not be treated as part of the Capitol*
4 *Visitor Center for purposes of this Act; and*

5 (2) *shall be treated for purposes of law (includ-*
6 *ing rules of the House of Representatives and Sen-*
7 *ate)*—

8 (A) *in the case of space assigned for the use*
9 *of the Senate, as part of the Senate wing of the*
10 *Capitol and subject to the authority and control*
11 *of the Committee on Rules and Administration*
12 *of the Senate, or*

13 (B) *in the case of space assigned for the use*
14 *of the House, as part of the House of Representa-*
15 *tives wing of the Capitol and subject to the au-*
16 *thority and control of the Speaker.*

17 (b) *TREATMENT OF CONGRESSIONAL AUDITORIUM AND*
18 *RELATED ADJACENT AREAS.*—

19 (1) *IN GENERAL.*—*Notwithstanding any other*
20 *provision of this Act, the space in the Capitol Visitor*
21 *Center known as the Congressional Auditorium, to-*
22 *gether with each of the areas referred to in paragraph*
23 *(2), shall be assigned for Congressional use by the*
24 *Chief Executive Officer for Visitor Services under*
25 *guidelines established by the supervising Committees.*

1 (2) *AREAS DESCRIBED.*—*The areas referred to in*
2 *this paragraph are as follows, as identified and des-*
3 *ignated by the Architect of the Capitol on October 1,*
4 *2007:*

5 (A) *The North Congressional Meeting Room*
6 *(CVC268) and the South Congressional Meeting*
7 *Room (CVC217).*

8 (B) *The North Pre-function Area*
9 *(CVC268CR) and the South Pre-function Area*
10 *(CVC217CR).*

11 (C) *Lobbies CVC215 and CVC212.*

12 (D) *The North Cloak Room (CVC210) and*
13 *the South Cloak Room (CVC208).*

14 (E) *The Projection Room (CVC209).*

15 (F) *The Green Room (CVC207).*

16 (G) *The TV Control Room (CVC105).*

17 (H) *Offices CVC101, CVC102, CVC103,*
18 *CVC104, CVC106, CVC204, and CVC205.*

19 ***Subtitle B—Office of the Capitol***
20 ***Visitor Center; Chief Executive***
21 ***Officer for Visitor Services***

22 ***SEC. 111. ESTABLISHMENT.***

23 *There is established within the Office of the Architect*
24 *of the Capitol the Office of the Capitol Visitor Center (in*
25 *this Act referred to as the “Office”), to be headed by the*

1 *Chief Executive Officer for Visitor Services (in this Act re-*
2 *ferred to as the “Chief Executive Officer”).*

3 **SEC. 112. APPOINTMENT AND SUPERVISION OF CHIEF EX-**
4 **ECUTIVE OFFICER FOR VISITOR SERVICES.**

5 (a) *APPOINTMENT.*—*The Chief Executive Officer shall*
6 *be appointed by the Architect of the Capitol.*

7 (b) *SUPERVISION AND OVERSIGHT.*—*The Chief Execu-*
8 *tive Officer shall report directly to the Architect of the Cap-*
9 *itol and shall be subject to policy review and oversight by*
10 *the supervising Committees.*

11 (c) *REMOVAL.*—*Upon removal of the Chief Executive*
12 *Officer, the Architect of the Capitol shall immediately notify*
13 *the supervising Committees and the Committees on Appro-*
14 *priations of the House of Representatives and Senate, stat-*
15 *ing the reasons for the removal.*

16 (d) *COMPENSATION.*—*The Chief Executive Officer shall*
17 *be paid at an annual rate of pay equal to the annual rate*
18 *of pay of the Deputy Architect of the Capitol and Chief Op-*
19 *erating Officer of the Office of the Architect of the Capitol.*

20 (e) *TRANSITION FOR CURRENT CHIEF EXECUTIVE OF-*
21 *FICER FOR VISITOR SERVICES.*—

22 (1) *APPOINTMENT.*—*The individual who serves*
23 *as the Chief Executive Officer for Visitor Services*
24 *under section 6701 of the U.S. Troop Readiness, Vet-*
25 *erans’ Care, Katrina Recovery, and Iraq Account-*

1 *ability Appropriation Act of 2007 (2 U.S.C. 1806) as*
2 *of the date of the enactment of this Act shall be the*
3 *first Chief Executive Officer for Visitor Services ap-*
4 *pointed by the Architect under this section.*

5 (2) *CONFORMING AMENDMENT.—Section 6701 of*
6 *the U.S. Troop Readiness, Veterans' Care, Katrina*
7 *Recovery, and Iraq Accountability Appropriation Act*
8 *of 2007 (2 U.S.C. 1806) is repealed.*

9 **SEC. 113. GENERAL DUTIES OF CHIEF EXECUTIVE OFFICER.**

10 (a) *ADMINISTRATION OF FACILITIES, SERVICES, AND*
11 *ACTIVITIES.—*

12 (1) *IN GENERAL.—Except to the extent otherwise*
13 *provided in this Act, the Chief Executive Officer shall*
14 *be responsible for—*

15 (A) *the operation, management, and budget*
16 *preparation and execution of the Capitol Visitor*
17 *Center, including all long term planning and*
18 *day-to-day operational services and activities*
19 *provided within the Capitol Visitor Center; and*

20 (B) *in accordance with subtitle A of title*
21 *III, the management of guided tours of the inte-*
22 *rior of the United States Capitol.*

23 (2) *INDEPENDENT BUDGET SUBMISSION.—*

24 (A) *IN GENERAL.—The proposed budget for*
25 *the Office for a fiscal year shall be prepared by*

1 *the Chief Executive Officer, and shall be included*
2 *without revision in the proposed budget for the*
3 *year for the Office of the Architect of the Capitol*
4 *(as submitted by the Architect of the Capitol to*
5 *the President).*

6 *(B) EXCLUSION OF COSTS OF GENERAL*
7 *MAINTENANCE AND REPAIR OF VISITOR CEN-*
8 *TER.—In preparing the proposed budget for the*
9 *Office under subparagraph (A), the Chief Execu-*
10 *tive Officer shall exclude costs attributable to the*
11 *activities and services described in section 115(b)*
12 *(relating to continuing jurisdiction of the Archi-*
13 *tect of the Capitol for the care and superintend-*
14 *ence of the Capitol Visitor Center).*

15 *(b) PERSONNEL AND OTHER ADMINISTRATIVE PROVI-*
16 *SIONS.—*

17 *(1) PERSONNEL, DISBURSEMENTS, AND CON-*
18 *TRACTS.—In carrying out this Act, the Chief Execu-*
19 *tive Officer shall have the authority—*

20 *(A) to appoint, hire, and fix the compensa-*
21 *tion of such personnel as may be necessary for*
22 *operations of the Office, except that no employee*
23 *may be paid at an annual rate in excess of the*
24 *maximum rate payable for level 15 of the Gen-*
25 *eral Schedule unless otherwise authorized by law;*

1 (B) to disburse funds as may be necessary
2 and available for the needs of the Office (con-
3 sistent with the requirements of section 213 in
4 the case of amounts in the Capitol Visitor Center
5 Revolving Fund); and

6 (C) to designate an employee of the Office to
7 serve as contracting officer for the Office, subject
8 to subsection (c).

9 (2) *TEMPORARY ASSIGNMENT OF PERSONNEL.*—

10 *The Chief Executive Officer shall temporarily assign*
11 *personnel of the Office based on a request from the*
12 *Capitol Police Board to assist the United States Cap-*
13 *itol Police by providing ushering and informational*
14 *services, and other services not directly involving law*
15 *enforcement, in connection with—*

16 (A) *the inauguration of the President and*
17 *Vice President of the United States;*

18 (B) *the official reception of representatives*
19 *of foreign nations and other persons by the Sen-*
20 *ate or House of Representatives; or*

21 (C) *other special or ceremonial occasions in*
22 *the United States Capitol or on the United*
23 *States Capitol Grounds that require the presence*
24 *of additional Government personnel.*

1 (3) *AGREEMENTS WITH THE OFFICE OF THE AR-*
2 *CHITECT OF THE CAPITOL, WITH OTHER LEGISLATIVE*
3 *BRANCH AGENCIES, AND WITH OFFICES OF THE SEN-*
4 *ATE AND HOUSE OF REPRESENTATIVES.*—*Subject to*
5 *the approval of the supervising Committees, the Chief*
6 *Executive Officer may place orders and enter into*
7 *agreements with the Office of the Architect of the Cap-*
8 *itol, with other legislative branch agencies, and with*
9 *any office or other entity of the Senate or House of*
10 *Representatives for procuring goods and providing fi-*
11 *nancial and administrative services on behalf of the*
12 *Office, or to otherwise assist the Chief Executive Offi-*
13 *cer in the administration and management of the*
14 *Capitol Visitor Center.*

15 (c) *REQUIRING APPROVAL OF CERTAIN CONTRACTS.*—
16 *The Chief Executive Officer may not enter into a contract*
17 *for which the amount involved exceeds \$250,000 without the*
18 *prior approval of the supervising Committees.*

19 (d) *SEMIANNUAL REPORTS.*—*The Chief Executive Of-*
20 *ficer shall submit a report to the supervising Committees*
21 *not later than 45 days following the close of each semi-*
22 *annual period ending on June 30 or December 31 of each*
23 *year on the financial and operational status during the pe-*
24 *riod of each function under the jurisdiction of the Chief Ex-*
25 *ecutive Officer. Each such report shall include financial*

1 *statements and a description or explanation of current op-*
2 *erations, the implementation of new policies and proce-*
3 *dures, and future plans for each function.*

4 **SEC. 114. ACCEPTANCE OF GIFTS AND VOLUNTEER SERV-**
5 **ICES.**

6 *(a) ACCEPTANCE OF GIFTS.—*

7 *(1) AUTHORITY TO ACCEPT AND USE GIFTS.—*

8 *The Chief Executive Officer, with the approval of the*
9 *supervising Committees, is authorized to receive, ac-*
10 *cept, and hold unrestricted gifts of money on behalf*
11 *of the Capitol Visitor Center, and to use the gifts for*
12 *the benefit of the Capitol Visitor Center*

13 *(2) ACCEPTANCE OF GIFTS OF WORKS OF ART*
14 *AND OTHER RELATED OBJECTS BY OTHER LEGISLA-*
15 *TIVE BRANCH ENTITIES.—*

16 *(A) IN GENERAL.—In the case of a gift con-*
17 *sisting of a work of art, historical object, or ex-*
18 *hibit for which the authority to accept the gift*
19 *for display in the Capitol is provided to an enti-*
20 *ty referred to in subparagraph (B), the entity*
21 *shall have the authority to accept the gift for dis-*
22 *play in the Capitol Visitor Center in accordance*
23 *with the authority provided under applicable*
24 *law.*

1 (B) *ENTITIES DESCRIBED.*—*The entities re-*
2 *ferred to in this subparagraph are as follows:*

3 (i) *The Joint Committee on the Li-*
4 *brary under section 1831 of the Revised*
5 *Statutes of the United States (2 U.S.C.*
6 *2133).*

7 (ii) *The United States Capitol Preser-*
8 *vation Commission under section 801 of the*
9 *Arizona-Idaho Conservation Act of 1988 (2*
10 *U.S.C. 2081).*

11 (iii) *The House of Representatives*
12 *Fine Arts Board under section 1000 of the*
13 *Arizona-Idaho Conservation Act of 1988 (2*
14 *U.S.C. 2121).*

15 (iv) *The Senate Commission on Art*
16 *under section 1 of Senate Resolution 382,*
17 *Ninetieth Congress, agreed to October 1,*
18 *1968 and enacted into law by section*
19 *901(a) of Public Law 100–690 (2 U.S.C.*
20 *2101).*

21 (3) *ANNUAL REPORT ON GIFTS ACCEPTED.*—
22 *Each semiannual report submitted under section*
23 *113(d) shall include a description of each accepted by*
24 *the Chief Executive Officer under this subsection dur-*
25 *ing the period covered by the report.*

1 (b) *ACCEPTANCE OF VOLUNTEER SERVICES.*—Not-
2 *withstanding section 1342 of title 31, United States Code,*
3 *the Chief Executive Officer may accept and use voluntary*
4 *and uncompensated services for the Capitol Visitor Center*
5 *as the Chief Executive Officer determines necessary. No per-*
6 *son shall be permitted to donate his or her personal services*
7 *under this section unless such person has first agreed, in*
8 *writing, to waive any and all claims against the United*
9 *States arising out of or connection with such services, other*
10 *than a claim under the provisions of chapter 81 of title*
11 *5, United States Code. No person donating personal services*
12 *under this section shall be considered an employee of the*
13 *United States for any purpose other than for purposes of*
14 *chapter 81 of such title. In no case shall the acceptance of*
15 *personal services under this subsection result in the reduc-*
16 *tion of pay or displacement of any employee of the Office.*

17 **SEC. 115. SPECIAL RULES REGARDING CERTAIN ADMINIS-**
18 **TRATIVE MATTERS.**

19 (a) *SPECIAL RULES REGARDING SECURITY.*—

20 (1) *SECURITY JURISDICTION OF LAW ENFORCE-*
21 *MENT AGENCIES UNAFFECTED.*—*Nothing in this Act*
22 *granting any authority to the Chief Executive Officer*
23 *shall be construed to affect the exclusive jurisdiction*
24 *of the United States Capitol Police, the Capitol Police*
25 *Board, the Sergeant at Arms and Doorkeeper of the*

1 *Senate, and the Sergeant at Arms of the House of*
2 *Representatives to provide security for the Capitol*
3 *Visitor Center.*

4 (2) *ATTENDANCE OF CHIEF EXECUTIVE OFFICER*
5 *AT CERTAIN MEETINGS OF CAPITOL POLICE BOARD.—*
6 *At the request of the Capitol Police Board, the Chief*
7 *Executive Officer shall attend any portion of any*
8 *meeting of the Capitol Police Board during which the*
9 *Board considers issues relating to the security of the*
10 *Capitol Visitor Center, including activities described*
11 *in paragraph (3), or other issues relating to services*
12 *provided by employees of the Office.*

13 (3) *CONSULTATION WITH CAPITOL POLICE BOARD*
14 *ON SECURITY MATTERS.—The Office shall consult*
15 *with the Capitol Police Board in carrying out any*
16 *activity which affects the security of the Capitol Vis-*
17 *itor Center or any other part of the Capitol, includ-*
18 *ing activities relating to the hours of operation, tour*
19 *routes and the number of visitors per tour guide, and*
20 *other activities relating to the entry of members of the*
21 *general public into the Capitol and the movement of*
22 *members of the general public within the Capitol.*

23 (4) *PLAN FOR BACKGROUND CHECKS FOR EM-*
24 *PLOYEES.—The Chief Executive Officer, in coordina-*
25 *tion with the Chief of the Capitol Police, shall develop*

1 *plans and procedures for conducting criminal history*
2 *background checks on employees of the Office and in-*
3 *dividuals seeking employment with the Office (includ-*
4 *ing employees of the Capitol Guide Service who are*
5 *transferred to the Office under title III).*

6 *(b) SPECIAL RULES REGARDING CARE AND MAINTENANCE OF FACILITIES.—*

8 *(1) ARCHITECT OF THE CAPITOL JURISDICTION*
9 *UNAFFECTED.—Nothing in this Act granting any au-*
10 *thority to the Chief Executive Officer (including sec-*
11 *tion 114) shall be construed to affect the exclusive ju-*
12 *risdiction of the Architect of the Capitol for the care*
13 *and superintendence of the Capitol Visitor Center or*
14 *any other part of the Capitol, and all maintenance*
15 *services, groundskeeping services, improvements, alter-*
16 *ations, additions, and repairs for the Capitol Visitor*
17 *Center shall be carried out pursuant to the direction*
18 *and supervision of the Architect subject to the over-*
19 *sight of Congress under applicable law (including*
20 *rules of the House of Representatives and Senate).*

21 *(2) BUDGET SUBMISSION.—The Architect of the*
22 *Capitol shall submit with the annual budget for the*
23 *Office of the Architect of the Capitol for a fiscal year*
24 *a separate, detailed statement of the costs anticipated*
25 *to be incurred during the year for the activities and*

1 *services described in paragraph (1) which are ex-*
2 *cluded from the annual budget for the Office which is*
3 *submitted by the Chief Executive Officer under section*
4 *113(a)(2).*

5 *(c) SPECIAL RULE REGARDING EXHIBITS AND*
6 *TOURS.—The Chief Executive Officer shall consider com-*
7 *ments and recommendations from the Clerk of the House*
8 *of Representatives and the Secretary of the Senate regard-*
9 *ing the content of exhibits contained in and tours operated*
10 *out of the Capitol Visitor Center.*

11 **TITLE II—RELATED SERVICES**
12 **PROVIDED AT CAPITOL VIS-**

14 **Subtitle A—Related Services**
15 **Described**

16 **SEC. 201. GIFT SHOP.**

17 *(a) ESTABLISHMENT.—In consultation with the super-*
18 *vising Committees, the Chief Executive Officer shall estab-*
19 *lish a gift shop within the Capitol Visitor Center for the*
20 *purpose of providing for the sale of gift items.*

21 *(b) EXCEPTION TO PROHIBITION OF SALE OR SOLICI-*
22 *TATION ON CAPITOL GROUNDS.—Section 5104(c) of title 40,*
23 *United States Code, shall not apply to any activity carried*
24 *out under this subsection.*

1 **SEC. 202. FOOD SERVICE OPERATIONS.**

2 (a) *RESTAURANT, CATERING, AND VENDING.*—The
3 *Chief Executive Officer is authorized to establish within the*
4 *Capitol Visitor Center a restaurant and other food service*
5 *facilities, including catering services and vending ma-*
6 *chines.*

7 (b) *USE OF CONTRACT TO CARRY OUT FOOD SERVICE*
8 *OPERATIONS.*—The *Chief Executive Officer shall carry out*
9 *all food service operations within the Capitol Visitor Center*
10 *pursuant to a contract entered into with a private vendor.*

11 (c) *EXCEPTION TO PROHIBITION OF SALE OR SOLICI-*
12 *TATION ON CAPITOL GROUNDS.*—Section 5104(c) of title 40,
13 *United States Code, shall not apply to any activity carried*
14 *out under this subsection.*

15 **SEC. 203. LICENSES AND OTHER AGREEMENTS FOR OPER-**
16 **ATIONS OR OTHER FUNCTIONS.**

17 (a) *AUTHORITY.*—The *Chief Executive Officer is au-*
18 *thorized—*

19 (1) *subject to the approval of the supervising*
20 *Committees, to enter into licenses and other agree-*
21 *ments to allow operations or other functions to occur*
22 *within the Capitol Visitor Center; and*

23 (2) *to assess and collect charges or other fees as*
24 *may be appropriate under such licenses and agree-*
25 *ments, including the recoupment of costs associated*
26 *with the operation or function being held.*

1 *other services by the gift shop established under section 201,*
2 *together with any interest accrued on balances in the Ac-*
3 *count.*

4 (b) *MISCELLANEOUS RECEIPTS ACCOUNT.*—*There*
5 *shall be deposited in the Miscellaneous Receipts Account*
6 *each of the following (together with any interest accrued on*
7 *balances in the Account):*

8 (1) *Any gifts of money accepted under section*
9 *114(a).*

10 (2) *Any net profits or commissions paid to the*
11 *Capitol Visitor Center under any contract for food*
12 *service operations entered into under section 202(b).*

13 (3) *Any charges or fees collected from the oper-*
14 *ations or other functions within the Capitol Visitor*
15 *Center under licenses or other arrangements entered*
16 *into under section 203(a).*

17 (4) *Any other receipts received from the oper-*
18 *ation of the Capitol Visitor Center*

19 **SEC. 213. USE OF MONIES.**

20 (a) *GIFT SHOP ACCOUNT.*—

21 (1) *IN GENERAL.*—*All monies in the Gift Shop*
22 *Account shall be available without fiscal year limita-*
23 *tion for obligation by the Chief Executive Officer in*
24 *connection with the operation of the gift shops under*
25 *section 201(a), including supplies, inventories, equip-*

1 *ment, and other expenses. In addition, such monies*
2 *may be used by the Chief Executive Officer to reim-*
3 *burse any applicable appropriations account for*
4 *amounts used from such appropriations account to*
