AN ACT

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to clarify that territories and Indian tribes are eligible to receive grants for confronting the use of methamphetamine.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Native American Meth-
3 amphetamine Enforcement and Treatment Act of 2007”.

4 **SEC. 2. NATIVE AMERICAN PARTICIPATION IN METH-**
5 **AMPHETAMINE GRANTS.**

6 (a) IN GENERAL.—Section 2996(a) of the Omnibus
7 Crime Control and Safe Streets Act of 1968 (42 U.S.C.
8 3797cc(a)) is amended—

9 (1) in paragraph (1)—

10 (A) in the matter preceding subparagraph
11 (A), by inserting “, territories, and Indian
12 tribes (as defined in section 2704)” after “to
13 assist States”; and

14 (B) in subparagraph (B), by striking “and
15 local” and inserting “, territorial, Tribal, and
16 local”;

17 (2) in paragraph (2), by inserting “, territories,
18 and Indian tribes” after “make grants to States”;
19 and

20 (3) in paragraph (3)(C), by inserting “, Trib-
21 al,” after “support State”.

22 (b) GRANT PROGRAMS FOR DRUG ENDANGERED
23 CHILDREN.—Section 755(a) of the USA PATRIOT Im-
24 provement and Reauthorization Act of 2005 (42 U.S.C.
25 3797cc–2(a)) is amended by inserting “, territories, and
26 Indian tribes (as defined in section 2704 of the Omnibus

1 Crime Control and Safe Streets Act of 1968 (42 U.S.C.
2 3797d))” after “make grants to States”.

3 (c) GRANT PROGRAMS TO ADDRESS METHAMPHET-
4 AMINE USE BY PREGNANT AND PARENTING WOMEN OF-
5 FENDERS.—Section 756 of the USA PATRIOT Improve-
6 ment and Reauthorization Act of 2005 (42 U.S.C.
7 3797cc–3) is amended—

8 (1) in subsection (a)(2), by inserting “, terri-
9 torial, or Tribal” after “State”;

10 (2) in subsection (b)—

11 (A) in paragraph (1)—

12 (i) by inserting “, territorial, or Trib-
13 al” after “State”; and

14 (ii) by striking “and/or” and inserting
15 “or”;

16 (B) in paragraph (2)—

17 (i) by inserting “, territory, Indian
18 tribe,” after “agency of the State”; and

19 (ii) by inserting “, territory, Indian
20 tribe,” after “criminal laws of that State”;
21 and

22 (C) by adding at the end the following:

23 “(3) INDIAN TRIBE.—The term ‘Indian tribe’
24 has the meaning given the term in section 2704 of

1 the Omnibus Crime Control and Safe Streets Act of
2 1968 (42 U.S.C. 3797d).”; and

3 (3) in subsection (c)—

4 (A) in paragraph (3), by striking “Indian
5 Tribes” and inserting “Indian tribes”; and

6 (B) in paragraph (4)—

7 (i) in the matter preceding subpara-
8 graph (A)—

9 (I) by striking “State’s”; and

10 (II) by striking “and/or” and in-
11 serring “or”;

12 (ii) in subparagraph (A), by striking
13 “State”;

14 (iii) in subparagraph (C), by inserting
15 “, Indian tribes,” after “involved coun-
16 ties”; and

17 (iv) in subparagraph (D), by inserting
18 “, Tribal” after “Federal, State”.
