Ms. SUTTON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3521) to improve the Operating Fund for public housing of the Department of Housing and Urban Development.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the State of the Union for consid-
5 eration of the bill (H.R. 3521) to improve the Operating
6 Fund for public housing of the Department of Housing
7 and Urban Development. The first reading of the bill shall

1 be dispensed with. All points of order against consider-
2 ation of the bill are waived except those arising under
3 clause 9 or 10 of rule XXI. General debate shall be con-
4 fined to the bill and shall not exceed one hour equally di-
5 vided and controlled by the chairman and ranking minor-
6 ity member of the Committee on Financial Services. After
7 general debate the bill shall be considered for amendment
8 under the five-minute rule. It shall be in order to consider
9 as an original bill for the purpose of amendment under
10 the five-minute rule the amendment in the nature of a sub-
11 stitute recommended by the Committee on Financial Serv-
12 ices now printed in the bill. The committee amendment
13 in the nature of a substitute shall be considered as read.
14 All points of order against the committee amendment in
15 the nature of a substitute are waived except those arising
16 under clause 10 of rule XXI. Notwithstanding clause 11
17 of rule XVIII, no amendment to the committee amend-
18 ment in the nature of a substitute shall be in order except
19 those printed in the report of the Committee on Rules ac-
20 companying this resolution. Each such amendment may
21 be offered only in the order printed in the report, may
22 be offered only by a Member designated in the report,
23 shall be considered as read, shall be debatable for the time
24 specified in the report equally divided and controlled by
25 the proponent and an opponent, shall not be subject to

1 amendment, and shall not be subject to a demand for divi-
2 sion of the question in the House or in the Committee
3 of the Whole. All points of order against such amendments
4 are waived except those arising under clause 9 or 10 of
5 rule XXI. At the conclusion of consideration of the bill
6 for amendment the Committee shall rise and report the
7 bill to the House with such amendments as may have been
8 adopted. Any Member may demand a separate vote in the
9 House on any amendment adopted in the Committee of
10 the Whole to the bill or to the committee amendment in
11 the nature of a substitute. The previous question shall be
12 considered as ordered on the bill and amendments thereto
13 to final passage without intervening motion except one
14 motion to recommit with or without instructions.

15 SEC. 2. During consideration in the House of H.R.
16 3521 pursuant to this resolution, notwithstanding the op-
17 eration of the previous question, the Chair may postpone
18 further consideration of the bill to such time as may be
19 designated by the Speaker.

20 SEC. 3. House Resolution 955 is laid upon the table.
