Mr. COLEMAN introduced the following bill; which was read twice and referred to the Committee on Environment and Public Works

## A BILL

To amend Public Law 87–383 to reauthorize appropriations to promote the conservation of migratory waterfowl and to offset or prevent the serious loss of important wetland and other waterfowl habitat essential to the preservation of migratory waterfowl, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. AUTHORIZATION OF FUNDS FOR CONSERVA-**  
4                               **TION OF MIGRATORY WATERFOWL AND HABI-**  
5                               **TAT.**

6       The first section of Public Law 87–383 (16 U.S.C.  
7       715k–3) is amended—

1           (1) by striking “That in” and inserting the fol-  
2           lowing:

3   **“SECTION 1. AUTHORIZATION OF FUNDS FOR CONSERVA-**  
4           **TION OF MIGRATORY WATERFOWL HABITAT.**

5           “(a) IN GENERAL.—In”;

6           (2) by striking “for the period” and all that fol-  
7           lows through the end of the sentence and inserting  
8           “\$400,000,000 for the period of fiscal years 2008  
9           through 2017.”; and

10          (3) by adding at the end the following:

11          “(b) ADVANCE TO MIGRATORY BIRD CONSERVATION  
12   FUND.—Funds appropriated pursuant to this Act shall be  
13   treated as an advance, without interest, to the Migratory  
14   Bird Conservation Fund.

15          “(c) REPAYMENT TO TREASURY.—

16               “(1) IN GENERAL.—Effective beginning July 1,  
17               2008, funds appropriated pursuant to this Act shall  
18               be repaid to the Treasury out of the Migratory Bird  
19               Conservation Fund.

20               “(2) AMOUNTS.—Repayment under this sub-  
21               section shall be made in annual amounts that are  
22               equal to the funds accruing annually to the Migra-  
23               tory Bird Conservation Fund that are attributable to  
24               the portion of the price of migratory bird hunting

1 stamps sold that year that is in excess of \$15 per  
2 stamp.”.

3 **SEC. 2. SENSE OF CONGRESS REGARDING THE USE OF CER-**  
4 **TAIN FUNDS.**

5 It is the sense of Congress that—

6 (1) the funds provided pursuant to the amend-  
7 ments made by this Act—

8 (A) should be used for preserving and in-  
9 creasing waterfowl populations in accordance  
10 with the goals and objectives of the North  
11 American Waterfowl Management Plan; and

12 (B) to that end, should be used to supple-  
13 ment and not replace current conservation  
14 funding, including funding for other Federal  
15 and State habitat conservation programs; and

16 (2) this Act and the amendments made by this  
17 Act should be implemented in a manner that helps  
18 private landowners achieve long-term land use objec-  
19 tives in a manner that enhances the conservation of  
20 wetland and wildlife habitat.
