# **A BILL**

To designate the facility of the Government Printing Office located at 31451 East United Avenue in Pueblo, Colorado, as the “Frank Evans Government Printing Office Building”.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION.**

4       The facility of the Government Printing Office lo-  
5 cated at ~~31451~~ East United Avenue in Pueblo, Colorado,  
6 shall be known and designated as the “Frank Evans Gov-  
7 ernment Printing Office Building”.

8 **SEC. 2. REFERENCES.**

9       Any reference in a law, map, regulation, document,  
10 record, or other paper of the United States to the facility  
11 referred to in section 1 shall be considered to be a ref-  
12 erence to the “Frank Evans Government Printing Office  
13 Building”.

14 **SECTION 1. DESIGNATION.**

15       *The building occupied by the Government Printing Of-*  
16 *fice located at 31451 East United Avenue in Pueblo, Colo-*  
17 *rado, shall be known and designated as the “Frank Evans*  
18 *Government Printing Office Building” during the period*  
19 *in which the building is occupied by the Government Print-*  
20 *ing Office.*

21 **SEC. 2. REFERENCES.**

22       *With respect to the period in which the building re-*  
23 *ferred to in section 1 is occupied by the Government Print-*  
24 *ing Office, any reference in a law, map, regulation, docu-*  
25 *ment, record, or other paper of the United States to that*

- 1 *building shall be deemed to be a reference to the “Frank*
- 2 *Evans Government Printing Office Building”.*

Amend the title so as to read: “A bill to designate the building occupied by the Government Printing Office located at 31451 East United Avenue in Pueblo, Colorado, as the ‘Frank Evans Government Printing Office Building’.”.
