## A BILL

To amend the Military Construction Authorization Act for Fiscal Year 2010 to authorize construction of an Aegis Ashore Test Facility at Pacific Missile Range Facility, Hawaii.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Aegis Ashore Test Fa-  
5       cility Construction Authorization Act”.

6       **SEC. 2. AUTHORIZATION.**

7       (a) **PROJECT AUTHORITY.**—The table entitled “Mis-  
8       sile Defense Agency” in section 2401 of the Military Con-

 2 B of Public Law 111–84) is amended by inserting after  
 3 the item relating to Redstone Arsenal, Alabama, the fol-  
 4 lowing new item:

5 (b) FISCAL YEAR 2009 AUTHORIZATION OF APPRO-  
 6 PRIATIONS.—Section 2403(a) of the Military Construction  
 7 Authorization Act for Fiscal Year 2009 (division B of  
 8 Public Law 110–417; 122 Stat. 4692), as amended by sec-  
 9 tion 2405(c)(1) of the Military Construction Authorization  
 10 Act for Fiscal Year 2010 (division B of Public Law 111–  
 11 84), is further amended—

12 (1) in the matter preceding paragraph (1), by  
 13 striking “\$1,487,890,000” and inserting  
 14 “\$1,556,390,000”; and

15 (2) in paragraph (2), by striking  
 16 “\$87,200,000” and inserting “\$163,700,000”.

17 (c) AMENDMENT TO FUNDING TABLE.—The table in  
 18 section 4501 of the National Defense Authorization Act  
 19 for Fiscal Year 2010 (Public Law 111–84) is amended  
 20 by inserting after the item relating to TFI–F–22 Parking  
 21 Apron and Taxiways at Hickam Air Force Base, Hawaii,  
 22 a Defense-wide account item for an Aegis Ashore Test Fa-

- 1 cility at Pacific Missile Range Facility, Kauai, Hawaii,
- 2 that is funded from prior year savings.
