A BILL

To amend the Federal Water Pollution Control Act and the Great Lakes Legacy Act of 2002 to reauthorize programs to address remediation of contaminated sediment.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Contaminated Sedi-
3 ment Remediation Reauthorization Act”.

4 **SEC. 2. REMEDIATION OF SEDIMENT CONTAMINATION IN**
5 **AREAS OF CONCERN.**

6 Section 118(c)(12)(H) of the Federal Water Pollu-
7 tion Control Act (33 U.S.C. 1268(c)(12)(H)) is amended
8 by striking clause (i) and inserting the following:

9 “(i) IN GENERAL.—In addition to
10 other amounts authorized under this sec-
11 tion, there is authorized to be appropriated
12 to carry out this paragraph—

13 “(I) \$50,000,000 for each of fis-
14 cal years 2004 through 2009; and

15 “(II) \$150,000,000 for each of
16 fiscal years 2010 through 2014.”.

17 **SEC. 3. PUBLIC INFORMATION PROGRAM.**

18 Section 118(c)(13)(B) of the Federal Water Pollution
19 Control Act (33 U.S.C. 1268(c)(13)(B)) is amended by
20 striking “2010” and inserting “2014”.

21 **SEC. 4. CONTAMINATED SEDIMENT REMEDIATION AP-**
22 **PROACHES, TECHNOLOGIES, AND TECH-**
23 **NIQUES.**

24 Section 106(b) of the Great Lakes Legacy Act of
25 2002 (33 U.S.C. 1271a(b)) is amended by striking para-
26 graph (1) and inserting the following:

1 “(1) IN GENERAL.—In addition to amounts au-
2 thorized under other laws, there are authorized to be
3 appropriated to carry out this section—

4 “(A) \$3,000,000 for each of fiscal years
5 2004 through 2009; and

6 “(B) \$5,000,000 for each of fiscal years
7 2010 through 2014.”.
