AN ACT

To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to notify Congress of conferences sponsored by the Department of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. QUARTERLY REPORTS TO CONGRESS ON CON-**
2 **FERENCES SPONSORED BY THE DEPART-**
3 **MENT.**

4 (a) IN GENERAL.—Subchapter I of chapter 5 of title
5 38, United States Code, is amended by adding at the end
6 the following new section:

7 **“§ 517. Quarterly reports to Congress on conferences**
8 **sponsored by the Department**

9 “(a) QUARTERLY REPORTS REQUIRED.—Not later
10 than 30 days after the end of each fiscal quarter, the Sec-
11 retary shall submit to the Committee on Veterans’ Affairs
12 of the House of Representatives and the Committee on
13 Veterans’ Affairs of the Senate a report on covered con-
14 ferences.

15 “(b) MATTERS INCLUDED.—Each report under sub-
16 section (a) shall include the following:

17 “(1) An accounting of the final costs to the De-
18 partment of each covered conference occurring dur-
19 ing the fiscal quarter preceding the date on which
20 the report is submitted, including the costs related
21 to—

22 “(A) transportation and parking;

23 “(B) per diem payments;

24 “(C) lodging;

25 “(D) rental of halls, auditoriums, or other
26 spaces;

1 “(E) rental of equipment;

2 “(F) refreshments;

3 “(G) entertainment;

4 “(H) contractors; and

5 “(I) brochures or other printed media.

6 “(2) The total estimated costs to the Depart-
7 ment for covered conferences occurring during the
8 fiscal quarter in which the report is submitted.

9 “(c) COVERED CONFERENCE DEFINED.—In this sec-
10 tion, the term ‘covered conference’ means a conference,
11 meeting, or other similar forum that is sponsored or co-
12 sponsored by the Department of Veterans Affairs and is—

13 “(1) attended by 50 or more individuals, includ-
14 ing one or more employees of the Department; or

15 “(2) estimated to cost the Department at least
16 \$20,000.”.

17 (b) CLERICAL AMENDMENT.—The table of sections
18 at the beginning of such chapter is amended by adding
19 after the item relating to section 516 the following:

“517. Quarterly reports to Congress on conferences sponsored by the Depart-
ment.”.

20 **SEC. 2. SUBMISSION OF CERTAIN INFORMATION BY THE**
21 **SECRETARY OF VETERANS AFFAIRS.**

22 (a) IN GENERAL.—Subchapter II of chapter 5 of title
23 38, United States Code, is amended by inserting after sec-
24 tion 529 the following new section:

1 **“§ 529A. Submission of certain information by the**
2 **Secretary to Congress**

3 “(a) IN GENERAL.—The submission of information
4 by the Secretary to the Committee on Veterans’ Affairs
5 of the House of Representatives or the Committee on Vet-
6 erans’ Affairs of the Senate in response to a request for
7 such information made by a covered member of the com-
8 mittee shall be deemed to be—

9 “(1) a covered disclosure under section
10 552a(b)(9) of title 5; and

11 “(2) a permitted disclosure under regulations
12 promulgated under section 264(c) of the Health In-
13 surance Portability and Accountability Act of 1996
14 (Public Law 104–191), including a permitted disclo-
15 sure for oversight activities authorized by law as de-
16 scribed in section 164.512(d) of title 45, Code of
17 Federal Regulations.

18 “(b) SUBMISSION TO CHAIRMAN.—With respect to a
19 request for information described in subsection (a) made
20 by a covered member of the committee who is not the
21 chairman, the Secretary shall also submit such informa-
22 tion to the chairman of the Committee on Veterans’ Af-
23 fairs of the House of Representatives or the Committee
24 on Veterans’ Affairs of the Senate, as the case may be.

1 “(c) COVERED MEMBER OF THE COMMITTEE.—In
2 this section, the term ‘covered member of the committee’
3 means the following:

4 “(1) The chairman or ranking member of the
5 Committee on Veterans’ Affairs of the House of
6 Representatives or the Committee on Veterans’ Af-
7 fairs of the Senate.

8 “(2) A chairman or ranking member of a sub-
9 committee of the Committee on Veterans’ Affairs of
10 the House of Representatives or the Committee on
11 Veterans’ Affairs of the Senate.

12 “(3) The designee of a chairman or ranking
13 member described in paragraph (1) or (2).”.

14 (b) CONFORMING AMENDMENT.—The table of sec-
15 tions at the beginning of such chapter is amended by in-
16 serting after the item relating to section 529 the following
17 new item:

“529A. Submission of certain information by the Secretary to Congress.”.

18 **SEC. 3. PUBLICATION OF DATA ON EMPLOYMENT OF CER-**
19 **TAIN VETERANS BY FEDERAL CONTRACTORS.**

20 Section 4212(d) of title 38, United States Code, is
21 amended by adding at the end the following new para-
22 graph:

23 “(3) The Secretary of Labor shall establish and
24 maintain an Internet website on which the Secretary shall

1 publicly disclose the information reported to the Secretary
2 of Labor by contractors under paragraph (1).”.
