14 *(a) IN GENERAL.—Section 32302(b) of title 49, United*  
15 *States Code, is amended by adding at the end the following:*  
16 *“The Secretary, after providing an opportunity for public*  
17 *comment, shall study and report to Congress the most useful*  
18 *data, format, and method for providing simple and under-*  
19 *standable damage susceptibility information to con-*  
20 *sumers.”.*

21 *(b) DEADLINE.—The Secretary of Transportation shall*  
22 *carry out the last sentence of section 32302(b) of title 49,*  
23 *United States Code, as added by subsection (a), not later*  
24 *than the date that is 2 years after the date of the enactment*  
25 *of this Act.*
