## A BILL

To remove from the John H. Chafee Coastal Barrier  
Resources System certain properties in South Carolina.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REMOVAL OF PROPERTIES IN SOUTH CARO-**  
4 **LINA FROM JOHN H. CHAFEE COASTAL BAR-**  
5 **RIER RESOURCES SYSTEM.**

6 (a) IN GENERAL.—The Secretary of the Interior shall  
7 revise one or more maps included in the set of maps enti-  
8 tled “Coastal Barrier Resources System” referred to in  
9 section 4(a) of the Coastal Barrier Resources Act (16  
10 U.S.C. 3503(a)), and relating to John H. Chafee Coastal
