## A BILL

To direct the Secretary of Agriculture to publish in the Federal Register a strategy to significantly increase the role of volunteers and partners in National Forest System trail maintenance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the  
5 “National Forest System Trails Stewardship Act”.

6 (b) TABLE OF CONTENTS.—The table of contents for  
7 this Act is as follows:

- Sec. 1. Short title; table of contents.
- Sec. 2. Findings.
- Sec. 3. Definitions.
- Sec. 4. National forest system trails volunteer and partnership strategy.
- Sec. 5. Priority trail maintenance program.

1 **SEC. 2. FINDINGS.**

2 Congress finds as follows:

3 (1) The National Forest System features a  
4 world-class trail system with over 157,000 miles of  
5 trails that provide world-class opportunities for hik-  
6 ing, horseback riding, hunting, mountain bicycling,  
7 motorized vehicles, and other outdoor activities.

8 (2) According to the Government Accountability  
9 Office, the Forest Service is only able to maintain  
10 about one-quarter of National Forest System trails  
11 to the agency standard, and the agency faces a trail  
12 maintenance backlog of \$314,000,000, and an addi-  
13 tional backlog of \$210,000,000 in annual mainte-  
14 nance, capital improvements, and operations.

15 (3) The lack of maintenance on National Forest  
16 System trails threatens access to public lands, and  
17 may cause increased environmental damage, threat-  
18 en public safety, and increase future maintenance  
19 costs.

20 (4) Federal budget limitations require solutions  
21 to National Forest System trail maintenance issues  
22 that make more efficient use of existing resources.

1           (5) Volunteers, partners, and outfitters and  
2 guides play an important role in maintaining Na-  
3 tional Forest System trails, and a comprehensive  
4 strategy is needed to ensure that volunteers and  
5 partners are used as effectively as possible.

6 **SEC. 3. DEFINITIONS.**

7 In this Act:

8           (1) ADMINISTRATIVE UNIT.—The term “Ad-  
9 ministrative Unit” means a national forest or na-  
10 tional grassland.

11           (2) OUTFITTER OR GUIDE.—The term “out-  
12 fitter or guide” means an individual, organization,  
13 or business who provides outfitting or guiding serv-  
14 ices, as defined in section 251.51 of title 36, Code  
15 of Federal Regulations.

16           (3) PARTNER.—The term “partner” means a  
17 non-Federal entity that engages in a partnership.

18           (4) PARTNERSHIP.—The term “partnership”  
19 means arrangements between the Department of Ag-  
20 riculture or the Forest Service and a non-Federal  
21 entity that are voluntary, mutually beneficial, and  
22 entered into for the purpose of mutually agreed  
23 upon objectives.

24           (5) PRIORITY AREA.—The term “priority area”  
25 means a well-defined region on National Forest Sys-

1 tem land selected by the Secretary under section  
2 5(a).

3 (6) SECRETARY.—The term “Secretary” means  
4 the Secretary of Agriculture.

5 (7) STRATEGY.—The term “strategy” means  
6 the National Forest System Trails Volunteer and  
7 Partnership Strategy authorized by section 4(a).

8 (8) TRAIL MAINTENANCE.—The term “trail  
9 maintenance” means any activity to maintain the  
10 usability and sustainability of trails within the Na-  
11 tional Forest System, including—

12 (A) ensuring trails are passable by the  
13 users for which they are managed;

14 (B) preventing environmental damage re-  
15 sulting from trail deterioration;

16 (C) protecting public safety; and

17 (D) averting future deferred maintenance  
18 costs.

19 (9) VOLUNTEER.—The term “Volunteer” has  
20 the same meaning given that term in section  
21 553.101 of title 29, Code of Federal Regulations.

22 **SEC. 4. NATIONAL FOREST SYSTEM TRAILS VOLUNTEER**  
23 **AND PARTNERSHIP STRATEGY.**

24 (a) IN GENERAL.—Not later than 2 years after the  
25 date of the enactment of this Act, the Secretary shall pub-

1 lish in the Federal Register a strategy to significantly in-  
2 crease the role of volunteers and partners in trail mainte-  
3 nance.

4 (b) REQUIRED ELEMENTS.—The strategy required  
5 by subsection (a) shall—

6 (1) augment and support the capabilities of  
7 Federal employees to carry out or contribute to trail  
8 maintenance;

9 (2) provide meaningful opportunities for volun-  
10 teers and partners to carry out trail maintenance in  
11 each region of the Forest Service;

12 (3) address the barriers to increased vol-  
13 unteerism and partnerships in trail maintenance  
14 identified by volunteers, partners, and others;

15 (4) prioritize increased volunteerism and part-  
16 nerships in trail maintenance in those regions with  
17 the most severe trail maintenance needs, and where  
18 trail maintenance backlogs are jeopardizing access to  
19 National Forest lands; and

20 (5) aim to increase trail maintenance by volun-  
21 teers and partners by 100 percent by the date that  
22 is 5 years after the date of the enactment of this  
23 Act.

24 (c) ADDITIONAL REQUIREMENT.—As a component of  
25 the strategy, the Secretary shall study opportunities to im-

1 prove trail maintenance by addressing opportunities to use  
2 fire crews in trail maintenance activities in a manner that  
3 does not jeopardize firefighting capabilities, public safety,  
4 or resource protection. Upon a determination that trail  
5 maintenance would be advanced by use of fire crews in  
6 trail maintenance, the Secretary shall incorporate these  
7 proposals into the strategy, subject to such terms and con-  
8 ditions as the Secretary determines to be necessary.

9 (d) VOLUNTEER LIABILITY.—

10 (1) IN GENERAL.—Section 3(d) of the Volun-  
11 teers in the National Forests Act of 1972 (16  
12 U.S.C. 558e(d)) is amended by inserting “, including  
13 a volunteer affiliated with a partner organization,”  
14 after “this Act”.

15 (2) ADDITIONAL REQUIREMENT.—Not later  
16 than 2 years after the date of the enactment of this  
17 Act, the Secretary shall adopt regulations imple-  
18 menting this section. These regulations shall ensure  
19 that the financial risk from claims or liability associ-  
20 ated with volunteers undertaking trail maintenance  
21 is shared by all administrative units.

22 (e) CONSULTATION.—The Secretary shall develop the  
23 strategy in consultation with volunteer and partner trail  
24 maintenance organizations, a broad array of outdoor  
25 recreation stakeholders, and other relevant stakeholders.

1 (f) VOLUNTEER AND PARTNERSHIP COORDINA-  
2 TION.—The Secretary shall require each administrative  
3 unit to develop a volunteer and partner coordination im-  
4 plementation plan for the strategy which clearly defines  
5 roles and responsibilities for the administrative unit and  
6 district staff, and includes strategies to ensure sufficient  
7 coordination, assistance, and support for volunteers and  
8 partners to improve trail maintenance.

9 (g) REPORT.—

10 (1) CONTENTS.—The Secretary shall prepare a  
11 report on—

12 (A) the effectiveness of the strategy in ad-  
13 dressing the trail maintenance backlog;

14 (B) the increase in volunteerism and part-  
15 nership efforts on trail maintenance as a result  
16 of the strategy;

17 (C) the miles of National Forest System  
18 trails maintained by volunteers and partners,  
19 and the approximate value of the volunteer and  
20 partnership efforts;

21 (D) the status of the stewardship credits  
22 for outfitters and guides pilot program de-  
23 scribed in section 7 that includes the number of  
24 participating sites, total amount of the credits  
25 offered, estimated value of trail maintenance

1 performed, and suggestions for revising the pro-  
2 gram; and

3 (E) recommendations for further increas-  
4 ing volunteerism and partnerships in trail main-  
5 tenance.

6 (2) SUBMISSION.—Not later than 3 years after  
7 the date of enactment of this Act, the Secretary  
8 shall submit the report required by paragraph (1)  
9 to—

10 (A) the Committee on Agriculture, Nutri-  
11 tion, and Forestry and the Committee on En-  
12 ergy and Natural Resources of the Senate; and

13 (B) the Committee on Agriculture and the  
14 Committee on Natural Resources of the House  
15 of Representatives.

16 **SEC. 5. PRIORITY TRAIL MAINTENANCE PROGRAM.**

17 (a) SELECTION.—In accordance with subsections (b)  
18 and (c), not later than 6 months after the date of the en-  
19 actment of this Act, the Secretary of Agriculture shall se-  
20 lect no fewer than 9 and no more than 15 priority areas  
21 for increased trail maintenance accomplishments.

22 (b) CRITERIA.—Priority areas shall include a well-de-  
23 fined region on National Forest System land where the  
24 lack of trail maintenance has—

25 (1) reduced access to public land;



1           (2) led to an increase, or risk of increase, in  
2           harm to natural resources;

3           (3) jeopardized public safety;

4           (4) resulted in trails being impassible by the in-  
5           tended managed users; or

6           (5) increased future deferred trail maintenance  
7           costs.

8           (c) REQUIREMENTS.—In selecting priority areas, the  
9           Secretary shall—

10           (1) consider any public input on priority areas  
11           received within 3 months of the date of enactment  
12           of this Act;

13           (2) consider the range of trail users (including  
14           motorized and non-motorized trail users); and

15           (3) include at least one priority area in each re-  
16           gion of the United States Forest Service.

17           (d) INCREASED TRAIL MAINTENANCE.—

18           (1) IN GENERAL.—Within 6 months of the se-  
19           lection of priority areas under subsection (a), and in  
20           accordance with paragraph (2), the Secretary shall  
21           develop an approach to substantially increase trail  
22           maintenance accomplishments within each priority  
23           area.

24           (2) CONTENTS.—In developing the approach  
25           under paragraph (1), the Secretary shall—

1 (A) consider any public input on trail  
2 maintenance priorities and needs within any  
3 priority area;

4 (B) consider the costs and benefits of in-  
5 creased trail maintenance within each priority  
6 area; and

7 (C) incorporate partners and volunteers in  
8 the trail maintenance.

9 (3) REQUIRED TRAIL MAINTENANCE.—Utilizing  
10 the approach developed under paragraph (1), the  
11 Secretary shall substantially increase trail mainte-  
12 nance within each priority area.

13 (e) COORDINATION.—The regional volunteer and  
14 partnership coordinators may be responsible for assisting  
15 partner organizations in developing and implementing vol-  
16 unteer and partnership projects to increase trail mainte-  
17 nance within priority areas.

18 (f) REVISION.—The Secretary shall periodically re-  
19 view the priority areas to determine whether revisions are  
20 necessary and may revise the priority areas, including the  
21 selection of new priority areas or removal of existing pri-  
22 ority areas, at his sole discretion.

23 **SEC. 6. COOPERATIVE AGREEMENTS.**

24 (a) IN GENERAL.—The Secretary may enter into a  
25 cooperative agreement (within the meaning of chapter 63

1 of title 31, United States Code) with any State, tribal,  
2 local governmental, and private entity to carry out this  
3 Act.

4 (b) CONTENTS.—Cooperative agreements authorized  
5 under this section may—

6 (1) improve trail maintenance in a priority  
7 area;

8 (2) implement the strategy; or

9 (3) advance trail maintenance in a manner  
10 deemed appropriate by the Secretary.

11 **SEC. 7. STEWARDSHIP CREDITS FOR OUTFITTERS AND**  
12 **GUIDES.**

13 (a) PILOT PROGRAM.—Within 1 year after the date  
14 of enactment of this Act, in accordance with this section,  
15 the Secretary shall establish a pilot program on not less  
16 than 20 administrative units to offset all or part of the  
17 land use fee for an outfitting and guiding permit by the  
18 cost of the work performed by the permit holder to con-  
19 struct, improve, or maintain National Forest System  
20 trails, trailheads, or developed sites that support public  
21 use under terms established by the Secretary.

22 (b) ADDITIONAL REQUIREMENTS.—In establishing  
23 the pilot program authorized by subsection (a), the Sec-  
24 retary shall—

- 1           (1) select administrative units where the pilot
- 2           program will improve trail maintenance; and
- 3           (2) establish appropriate terms and conditions,
- 4           including meeting National Quality Standards for
- 5           Trails and the Trail Management Objectives identi-
- 6           fied for the trail.
