Mr. BYRNE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 5143) to provide greater transparency and congressional oversight of international insurance standards setting processes, and for other purposes; providing for proceedings during the period from December 9, 2016, through January 3, 2017; and providing for consideration of motions to suspend the rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 5143) to provide greater transparency and congressional

1 oversight of international insurance standards setting  
2 processes, and for other purposes. All points of order  
3 against consideration of the bill are waived. In lieu of the  
4 amendment recommended by the Committee on Financial  
5 Services now printed in the bill, an amendment in the na-  
6 ture of a substitute consisting of the text of Rules Com-  
7 mittee Print 114-68 shall be considered as adopted. The  
8 bill, as amended, shall be considered as read. All points  
9 of order against provisions in the bill, as amended, are  
10 waived. The previous question shall be considered as or-  
11 dered on the bill, as amended, and on any further amend-  
12 ment thereto, to final passage without intervening motion  
13 except: (1) one hour of debate equally divided and con-  
14 trolled by the chair and ranking minority member of the  
15 Committee on Financial Services; (2) the further amend-  
16 ment printed in the report of the Committee on Rules ac-  
17 companying this resolution, if offered by the Member des-  
18 ignated in the report, which shall be in order without  
19 intervention of any point of order, shall be considered as  
20 read, shall be separately debatable for the time specified  
21 in the report equally divided and controlled by the pro-  
22 ponent and an opponent, and shall not be subject to a  
23 demand for a division of the question; and (3) one motion  
24 to recommit with or without instructions.

1        SEC. 2. On any legislative day of the second session  
2 of the One Hundred Fourteenth Congress after December  
3 8, 2016—

4        (a) the Journal of the proceedings of the previous day  
5 shall be considered as approved; and

6        (b) the Chair may at any time declare the House ad-  
7 journed to meet at a date and time, within the limits of  
8 clause 4, section 5, article I of the Constitution, to be an-  
9 nounced by the Chair in declaring the adjournment.

10       SEC. 3. The Speaker may appoint Members to per-  
11 form the duties of the Chair for the duration of the period  
12 addressed by section 2 of this resolution as though under  
13 clause 8(a) of rule I.

14       SEC. 4. Each day during the period addressed by sec-  
15 tion 2 of this resolution shall not constitute a calendar  
16 day for purposes of section 7 of the War Powers Resolu-  
17 tion (50 U.S.C. 1546).

18       SEC. 5. Each day during the period addressed by sec-  
19 tion 2 of this resolution shall not constitute a legislative  
20 day for purposes of clause 7 of rule XIII.

21       SEC. 6. It shall be in order at any time on the legisla-  
22 tive day of December 8, 2016, for the Speaker to entertain  
23 motions that the House suspend the rules as though under  
24 clause 1 of rule XV. The Speaker or his designee shall  
25 consult with the Minority Leader or her designee on the

- 1 designation of any matter for consideration pursuant to
- 2 this section.
