## A BILL

To expand eligibility for the program of comprehensive assistance for family caregivers of the Department of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Caregivers Access and  
5 Responsible Expansion for All Veterans Act” or the  
6 “CARE for All Veterans Act”.

1 **SEC. 2. EXPANSION OF ELIGIBILITY FOR PARTICIPATION IN**  
2 **FAMILY CAREGIVER PROGRAM OF DEPART-**  
3 **MENT OF VETERANS AFFAIRS.**

4 (a) **EXPANSION OF ELIGIBILITY.**—Subsection  
5 (a)(2)(B) of section 1720G of title 38, United States  
6 Code, is amended by inserting before the semicolon the  
7 following: “, or, in accordance with paragraph (11), has  
8 such an injury or illness that was so incurred or aggra-  
9 vated before such date”.

10 (b) **CLARIFICATION OF ELIGIBILITY FOR ILLNESS.**—  
11 Such subsection is further amended by inserting “or ill-  
12 ness” after “serious injury”.

13 (c) **EXPANSION OF NEEDED SERVICES IN ELIGI-**  
14 **BILITY CRITERIA.**—Subsection (a)(2)(C) of such section  
15 is amended—

16 (1) in clause (ii), by striking “; or” and insert-  
17 ing a semicolon;

18 (2) by redesignating clause (iii) as clause (iv);  
19 and

20 (3) by inserting after clause (ii) the following  
21 new clause (iii):

22 “(iii) a need for regular or extensive in-  
23 struction or supervision in completing two or  
24 more instrumental activities of daily living; or”.

1 (d) ELIGIBILITY FOR ASSISTANCE.—Subsection (a)  
2 of such section is amended by adding at the end the fol-  
3 lowing new paragraph:

4 “(11) Notwithstanding any other provision of this  
5 subsection, a family caregiver of an eligible veteran who  
6 is eligible under paragraph (2) solely because of a serious  
7 injury or illness (including traumatic brain injury, psycho-  
8 logical trauma, or other mental disorder) incurred or ag-  
9 gravated in the line of duty in the active military, naval,  
10 or air service before September 11, 2001, is eligible for  
11 assistance under this subsection as follows:

12 “(A) Not earlier than October 1, 2019, if the  
13 family caregiver would merit a monthly personal  
14 caregiver stipend under paragraph (3)(A)(ii)(V) in  
15 an amount that is in the highest tier specified in the  
16 schedule established by the Secretary under para-  
17 graph (3)(C)(i).

18 “(B) Not earlier than October 1, 2021, if the  
19 family caregiver would merit such a stipend in an  
20 amount that is in the middle tier specified in such  
21 schedule.

22 “(C) Not earlier than October 1, 2023, if the  
23 family caregiver would merit such a stipend in an

- 1 amount that is in the lowest tier specified in such
- 2 schedule.”.
