A BILL

To direct the Secretary of Veterans Affairs to conduct a review of the deaths of certain veterans who died by suicide, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veteran Suicide Pre-
5 vention Act”.

1 **SEC. 2. DEPARTMENT OF VETERANS AFFAIRS REVIEW OF**
2 **CERTAIN VETERANS' DEATHS BY SUICIDE.**

3 (a) REVIEW REQUIRED.—Not later than 18 months
4 after the date of the enactment of this Act, the Secretary
5 of Veterans Affairs shall complete a review of the deaths
6 of all covered veterans who died by suicide during the five-
7 year period preceding the date of the enactment of this
8 Act. Such review shall include—

9 (1) the total number of veterans who died by
10 suicide during the five-year period preceding the
11 date of the enactment of this Act;

12 (2) a summary of such veterans that includes
13 the age, gender, and race of such veterans;

14 (3) a comprehensive list of the medications pre-
15 scribed to, and found in the systems of, such vet-
16 erans at the time of their deaths, specifically listing
17 any medications that carried a black box warning,
18 were off-label, psychotropic, or carried warnings that
19 included suicidal ideation;

20 (4) a summary of medical diagnoses by Depart-
21 ment of Veterans Affairs physicians which led to the
22 prescribing of the medications referred to in para-
23 graph (3);

24 (5) the number of instances in which the vet-
25 eran who died by suicide was concurrently on mul-

1 multiple medications prescribed by Department of Vet-
2 erans Affairs physicians;

3 (6) the percentage of veterans who died by sui-
4 cide who were not taking any medication prescribed
5 by a Department of Veterans Affairs physician;

6 (7) the percentage of veterans referred to in
7 paragraph (1) with combat experience or trauma
8 (including, but not limited to military sexual trauma,
9 traumatic brain injury, and post-traumatic stress);

10 (8) Veterans Health Administration facilities
11 with markedly high prescription and suicide rates of
12 patients being treated at those facilities;

13 (9) a description of Department of Veterans Af-
14 fairs policies governing the prescribing of medica-
15 tions referred to in paragraph (3);

16 (10) any patterns apparent to the Secretary
17 based on the review; and

18 (11) recommendations for further action that
19 would improve the safety and well-being of veterans.

20 (b) PUBLIC AVAILABILITY.—Not later than 30 days
21 after the completion of the review required under sub-
22 section (a), the Secretary shall—

23 (1) submit to Congress a report on the results
24 of the review; and

25 (2) make such report publicly available.

1 (c) COVERED VETERAN.—In this section:

2 (1) The term “covered veteran” means any vet-
3 eran who received hospital care or medical services
4 furnished by the Department of Veterans Affairs
5 during the five-year period preceding the death of
6 the veteran.

7 (2) The term “black box warning” means a
8 warning displayed within a box in the prescribing in-
9 formation for drugs that have special problems, par-
10 ticularly ones that may lead to death or serious in-
11 jury.
