A BILL

To amend title 18, United States Code, to improve the
Law Enforcement Officer Safety Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “LEOSA Reform Act”.

5 **SEC. 2. IMPROVEMENTS TO THE LAW ENFORCEMENT OFFI-**
6 **CER SAFETY ACT.**

7 (a) ALLOWING QUALIFIED CURRENT OR RETIRED
8 LAW ENFORCEMENT OFFICERS TO CARRY A FIREARM IN
9 A SCHOOL ZONE.—Section 922(q)(2)(B) of title 18,
10 United States Code, is amended—

1 (1) by striking “or” at the end of clause (vi);

2 (2) by striking the period at the end of clause

3 (vii) and inserting “; or”; and

4 (3) by adding at the end the following:

5 “(viii) by an individual authorized by

6 section 926B or 926C to carry a concealed

7 firearm.”.

8 (b) ALLOWING QUALIFIED CURRENT OR RETIRED

9 LAW ENFORCEMENT OFFICERS TO CARRY A FIREARM ON

10 PROPERTY OPEN TO THE PUBLIC (INCLUDING ON AM-

11 TRAK).—Each of paragraphs (1) and (2) of sections

12 926B(b) and 926C(b) of such title are amended by insert-

13 ing “, except to the extent that the laws apply to property

14 open to the public” before the semicolon.

15 (c) ALLOWING QUALIFIED CURRENT OR RETIRED

16 LAW ENFORCEMENT OFFICERS TO CARRY A FIREARM IN

17 A NATIONAL PARK.—Each of sections 926B(a) and

18 926C(a) of such title is amended by inserting “or any reg-

19 ulation prescribed by the Secretary of the Interior per-

20 taining to a unit of the National Park System” after

21 “thereof”.

22 (d) ALLOWING QUALIFIED CURRENT OR RETIRED

23 LAW ENFORCEMENT OFFICERS TO CARRY AN AMMUNI-

24 TION MAGAZINE OF ANY CAPACITY.—Each of sections

25 926B(e)(2) and 926C(e)(1)(B) of such title is amended

1 by inserting “and an ammunition magazine” before “not
2 expressly”.

3 (e) ALLOWING RETIRED LAW ENFORCEMENT OFFI-
4 CERS TO QUALIFY FOR CONCEALED CARRY BY PASSING
5 A STATE-APPROVED QUALIFICATION COURSE FOR RE-
6 TIRED OFFICERS OR A COURSE NEEDED TO OBTAIN A
7 CONCEALED CARRY PERMIT IN THE STATE.—Section
8 926C(d)(2)(B) of such title is amended—

9 (1) in the matter preceding clause (I), by strik-
10 ing “active duty officers” each place it appears;

11 (2) in clause (I)—

12 (A) by striking “active duty”; and

13 (B) by striking “or” at the end;

14 (3) in clause (II), by striking the period and in-
15 serting “; or”; and

16 (4) by adding at the end the following:

17 “(III) the standards set by the agency
18 referred to in paragraph (1) to carry a
19 firearm of the same type as the concealed
20 firearm.”.
