## RESOLUTION

Providing for consideration of the bill (H.R. 26) to amend chapter 8 of title 5, United States Code, to provide that major rules of the executive branch shall have no force or effect unless a joint resolution of approval is enacted into law, and providing for consideration of the resolution (H. Res. 11) objecting to United Nations Security Council Resolution 2334 as an obstacle to Israeli-Palestinian peace, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 26) to amend chapter 8 of title  
6 5, United States Code, to provide that major rules of the  
7 executive branch shall have no force or effect unless a joint  
8 resolution of approval is enacted into law. The first read-  
9 ing of the bill shall be dispensed with. All points of order  
10 against consideration of the bill are waived. General de-  
11 bate shall be confined to the bill and shall not exceed one  
12 hour equally divided and controlled by the Majority Leader  
13 and the Minority Leader or their respective designees.  
14 After general debate the bill shall be considered for  
15 amendment under the five-minute rule. The bill shall be  
16 considered as read. All points of order against provisions  
17 in the bill are waived. No amendment to the bill shall be  
18 in order except those printed in the report of the Com-  
19 mittee on Rules accompanying this resolution. Each such  
20 amendment may be offered only in the order printed in  
21 the report, may be offered only by a Member designated  
22 in the report, shall be considered as read, shall be debat-  
23 able for the time specified in the report equally divided  
24 and controlled by the proponent and an opponent, shall  
25 not be subject to amendment, and shall not be subject to

1 a demand for division of the question in the House or in  
2 the Committee of the Whole. All points of order against  
3 such amendments are waived. At the conclusion of consid-  
4 eration of the bill for amendment the Committee shall rise  
5 and report the bill to the House with such amendments  
6 as may have been adopted. The previous question shall  
7 be considered as ordered on the bill and amendments  
8 thereto to final passage without intervening motion except  
9 one motion to recommit with or without instructions.

10 SEC. 2. Upon adoption of this resolution it shall be  
11 in order without intervention of any point of order to con-  
12 sider in the House the resolution (H. Res. 11) objecting  
13 to United Nations Security Council Resolution 2334 as  
14 an obstacle to Israeli-Palestinian peace, and for other pur-  
15 poses. The resolution shall be considered as read. The pre-  
16 vious question shall be considered as ordered on the reso-  
17 lution and preamble to adoption without intervening mo-  
18 tion or demand for division of the question except one hour  
19 of debate equally divided and controlled by the chair and  
20 ranking minority member of the Committee on Foreign  
21 Affairs.
