AN ACT

To amend title 38, United States Code, to improve the provision of adult day health care services for veterans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "State Veterans Home
- 3 Adult Day Health Care Improvement Act of 2017".
- 4 SEC. 2. PROVISION OF CERTAIN ADULT DAY HEALTH CARE
- 5 SERVICES FOR VETERANS.
- 6 (a) In General.—Section 1745 of title 38, United
- 7 States Code, is amended—
- 8 (1) by adding at the end the following new sub-
- 9 section:
- "(d)(1) The Secretary shall enter into an agreement
- 11 with each State home for payment by the Secretary for
- 12 medical supervision model adult day health care provided
- 13 to a veteran described in subsection (a)(1) on whose behalf
- 14 the State home is not in receipt of payment for nursing
- 15 home care from the Secretary.
- 16 "(2)(A) Payment under each agreement between the
- 17 Secretary and a State home under paragraph (1) for each
- 18 veteran who receives medical supervision model adult day
- 19 health care under such agreement shall be made at a rate
- 20 established through regulations prescribed by the Sec-
- 21 retary to adequately reimburse the State home for the care
- 22 provided by the State home, including necessary transpor-
- 23 tation expenses.
- 24 "(B) The Secretary shall consult with the State
- 25 homes in prescribing regulations under subparagraph (A).

- 1 "(C) The rate established through regulations under
- 2 subparagraph (A) shall not take effect until the date that
- 3 is 30 days after the date on which those regulations are
- 4 published in the Federal Register.
- 5 "(3) Payment by the Secretary under paragraph (1)
- 6 to a State home for medical supervision model adult day
- 7 health care provided to a veteran described in that para-
- 8 graph constitutes payment in full to the State home for
- 9 such care furnished to that veteran.
- 10 "(4) In this subsection, the term 'medical supervision
- 11 model adult day health care' means adult day health care
- 12 that includes the coordination of physician services, dental
- 13 services, nursing services, the administration of drugs, and
- 14 such other requirements as determined appropriate by the
- 15 Secretary."; and
- 16 (2) in the section heading, by inserting ",
- adult day health care," after "home care".
- 18 (b) Initial Rate.—Before the Secretary of Veterans
- 19 Affairs establishes a payment rate under subsection
- 20 (d)(2)(A) of section 1745 of such title, as added by sub-
- 21 section (a), the Secretary shall pay to a State home that
- 22 has entered into an agreement with the Secretary for med-
- 23 ical supervision model adult day health care (as defined
- 24 in subsection (d)(4) of such section) an amount equal to
- 25 65 percent of the rate the Secretary would pay under sub-

- 1 section (a)(2) of such section to the State home for nurs-
- 2 ing home care provided to the veteran.
- 3 (c) Clerical Amendment.—The table of sections
- 4 at the beginning of chapter 17 of such title is amended
- 5 by striking the item relating to section 1745 and inserting
- 6 the following new item:

"1745. Nursing home care, adult day health care, and medications for veterans with service-connected disabilities.".
