**UNANIMOUS CONSENT AGREEMENT**

## S. RES. 64 (ORDER NO. 20)

*Ordered*, That on Tuesday, March 5, 2013, at a time to be determined by the Majority Leader, after consultation with the Republican Leader, the Senate proceed to the consideration of S. Res. 64, an original resolution authorizing expenditures by the Committee on Commerce, Science, and Transportation; provided, that the only amendment in order be an amendment, to be offered by the Senator from Kentucky (Mr. Paul), striking provisions relative to the National Security Working Group; provided further, that there be up to 30 minutes of debate, equally divided and controlled in the usual form on the amendment; further, that upon the use or yielding back of time, the Senate vote on the amendment, and that upon the disposition of the Paul amendment, the Senate vote on adoption of the resolution, as amended, if amended. (*Feb. 28, 2013.*)
