UNANIMOUS CONSENT AGREEMENTS

S. 1243 (ORDER NO. 99)

1.—*Ordered*, That following Leader remarks on Wednesday, July 31, 2013, the Senate resume consideration of S. 1243, an original bill making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2014, and for other purposes; provided, that the pending amendments be set aside and the Senator from Kentucky (Mr. Paul) be recognized to offer Amdt. No. 1739; provided further, that there be 60 minutes for debate equally divided and controlled between the proponents and opponents; provided further, that upon the use or yielding back of time, the Senate vote in relation to the amendment; further, that no points of order or second degree amendments be in order to the amendment prior to the vote.

Ordered further, That the text of H.R. 2610, as reported by the House Appropriations Committee, be deemed House-passed text for the purposes of Rule XVI.

Ordered further, That with respect to the cloture motion filed on S. 1243, the mandatory quorum required under Rule XXII be waived. (*July 18, 30, 2013.*)

S. 1238 (ORDER NO. 124)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1238, a bill to amend the Higher Education Act of 1965 to extend the current reduced interest rate for undergraduate Federal Direct Stafford Loans for 1 year, to modify required distribution rules for pension plans, and for other purposes; provided, that the mandatory quorum required under Rule XXII be waived. (*July 8, 2013.*)
