to Jesuit High School in Portland, OR, to teach freshman theology and coach the mighty JV II girls' softball team. Also served as the Oregon Province's Provincial Assistant for Formation and as superior of the Jesuit community at Jesuit High School in Portland. Sworn in as 60th House Chaplain on May 25, 2011.
