Copies also may be obtained by mail.

**§ 391.3 Overtime and holiday rate.**

The overtime and holiday rate for inspection services provided pursuant to §§307.5, 350.7, 351.8, 351.9, 352.5, 354.101, 355.12, 362.5 and 381.38 shall be \$39.76 per hour per program employee.

**§ 391.4 Laboratory services rate.**

The rate for laboratory services provided pursuant to §§350.7, 351.9, 352.5, 354.101, 355.12 and 362.5 shall be \$58.52 per hour per program employee.

**§ 391.5 Laboratory accreditation fees.**

(a) The annual fee for the initial accreditation and maintenance of accreditation provided pursuant to §§318.21 and 381.153 shall be \$1,500 per accreditation.

(b) Laboratories that request special onsite inspections shall pay FSIS the actual cost of reasonable travel and other expenses necessary to perform the unscheduled or non-routine onsite inspections.
