Signed on November 6, 2009. (Public Law 111-91)

H.R. 3548, to amend the Supplemental Appropriations Act, 2008 to provide for the temporary availability of certain additional emergency unemployment compensation. Signed on November 6, 2009. (Public Law 111-92)

H.R. 3606, to amend the Truth in Lending Act to make a technical correction to an amendment made by the Credit CARD Act of 2009. Signed on November 6, 2009. (Public Law 111-93)

H.J. Res. 26, proclaiming Casimir Pulaski to be an honorary citizen of the United States posthumously. Signed on November 6, 2009. (Public Law 111-94)

S. 832, to amend title 36, United States Code, to grant a Federal charter to the Military Officers Association of America. Signed on November 6, 2009. (Public Law 111-95)

S. 1694, to allow the funding for the interoperable emergency communications grant program established under the Digital Television Transition and Public Safety Act of 2005 to remain available until expended through fiscal year 2012. Signed on November 6, 2009. (Public Law 111-96)
