*Committee on Veterans' Affairs:* Committee concluded a hearing to examine S. 49, to amend title 38, United States Code, to ensure that veterans in each of the 48 contiguous States are able to receive services in at least one full-service Department of Veterans Affairs medical center in the State or receive comparable services provided by contract in the State, S. 62, to amend the Internal Revenue Code of 1986 to allow taxpayers to designate overpayments of tax as contributions and to make additional contributions to the Homeless Veterans Assistance Fund, S. 131, to amend title 38, United States Code, to improve the reproductive assistance provided by the Department of Veterans Affairs to severely wounded, ill, or injured veterans and their spouses, S. 229, to designate the medical center of the Department of Veterans Affairs located at 3900 Woodland Avenue in Philadelphia, Pennsylvania, as the "Corporal Michael J. Crescenz Department of Veterans Affairs Medical Center", S. 287, to amend title 38, United States Code, to expand the definition of homeless veteran for purposes of benefits under the laws administered by the Secretary of Veterans Affairs, S. 325, to amend title 38, United States Code, to increase the maximum age for children eligible for medical care under the CHAMPVA program, S. 412, to authorize certain major medical facility leases for the Department of Veterans Affairs, S. 422, to amend the Department of Veterans Affairs Health Care Programs Enhancement Act of 2001 and title 38, United States Code, to require the provision of chiropractic care and services to veterans at all Department of Veterans Affairs medical centers and to expand access to such care and services, S. 455, to amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to transport individuals to and from facilities of the Department of Veterans Affairs in connection with rehabilitation, counseling, examination, treatment, and care, S. 522, to require the Secretary of Veterans Affairs to award grants to establish, or expand upon, master's degree or doctoral degree programs in orthotics and prosthetics, S. 529, to amend title 38, United States Code, to modify the commencement date of the period of service at Camp Lejeune, North Carolina, for eligibility for hospital care and medical services in connection with exposure to contaminated water, S. 543, to require the Secretary of Veterans Affairs to reorganize the

Veterans Integrated Service Networks of the Veterans Health Administration, S. 633, to amend title 38, United States Code, to provide for coverage under the beneficiary travel program of the Department of Veterans Affairs of certain disabled veterans for travel in connection with certain special disabilities rehabilitation, S. 800, to require the Secretary of Veterans Affairs to ensure that the South Texas Department of Veterans Affairs Health Care Center at Harlingen, located in Harlingen, Texas, includes a full-service inpatient health care facility of the Department of Veterans Affairs, to redesignate such center, S. 825, to amend title 38, United States Code, to improve the provision of services for homeless veterans, S. 832, to require the Secretary of Veterans Affairs to carry out pilot programs on furnishing case management services and assisted living to children of Vietnam veterans and certain Korea service veterans born with spina bifida and children of women Vietnam veterans born with certain birth defects, S. 845, to amend title 38, United States Code, to improve the Department of Veterans Affairs Health Professionals Educational Assistance Program, S. 851, to amend title 38, United States Code, to extend to all veterans with a serious service-con-

**Full Faith and Credit Act:** The House passed H.R. 807, to require that the Government prioritize all obligations on the debt held by the public in the event that the debt limit is reached, by a yea-and-nay vote of 221 yeas to 207 nays, Roll No. 142.

**Pages H2539–53**

Rejected the Maffei motion to recommit the bill to the Committee on Ways and Means with instruc-

tions to report the same back to the House forthwith with an amendment, by a recorded vote of 200 yeas to 227 noes, Roll No. 141. **Pages H2551–53**

Camp amendment (printed in H. Rept. 113–52) that clarifies the prohibition on compensation for Members of Congress and clarifies language to require that the Secretary report to Congress anytime the new authority is used (by a yea-and-nay vote of 340 yeas to 84 nays, Roll No. 140). **Pages H2546–51**

H. Res. 202, the rule providing for consideration of H.R. 807, was agreed to yesterday, May 8th.
