REPORT

[To accompany H. Res. 538]

The Committee on Rules, having had under consideration House Resolution 538, by a record vote of 7 to 1, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF RESOLUTION

The resolution provides for the consideration of H.R. 4461, the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2001, under an open rule. The rule provides one hour of general debate divided equally between the chairman and ranking minority member of the Committee on Appropriations.

The rule waives all points of order against consideration of the bill. The rule also waives points of order against provisions in the bill for failure to comply with clause 2 of rule XXI (prohibiting unauthorized or legislative provisions in a general appropriations bill), except as specified in the rule. The rule provides that the bill shall be considered for amendment by paragraph. The rule allows the Chairman of the Committee of the Whole to accord priority in recognition to Members who have preprinted their amendments in the Congressional Record. Further, the rule allows the Chairman of the Committee of the Whole to postpone a request for a recorded vote on any amendment and reduce voting time to five minutes on a postponed question, provided that the minimum time for electronic voting on the first in any series of questions shall be fifteen minutes. The rule provides one motion to recommit with or without instructions. Finally, the rule provides that H. Res. 513 is laid on the table.

The waiver of all points of order against consideration of the bill includes a waiver of section 306 of the Congressional Budget Act of 1974 (prohibiting consideration of legislation within the Budget Committee's jurisdiction). The waiver of clause 2 of rule XXI is necessary because the bill contains many legislative provisions and several unauthorized provisions, which are listed on page 137 in the report to accompany H.R. 4461 (H. Rpt. 106-619).
