¶67.7 SILVIO CONTE DISABILITIES PREVENTION ACT

Mr. WAXMAN moved to suspend the rules and pass the bill (H.R. 2204) to amend the Public Health Service Act to establish a program for the prevention of disabilities, and for other purposes.

The SPEAKER pro tempore, Mr. MAZZOLI, recognized Mr. WAXMAN and Mr. MOORHEAD, each for 20 minutes.

After debate,

The question being put, *viva voce*,

Will the House suspend the rules and pass said bill?

The SPEAKER pro tempore, Mr. MAZZOLI, announced that two-thirds of the Members present had voted in the affirmative.

So, two-thirds of the Members present having voted in favor thereof, the rules were suspended and said bill was passed.

A motion to reconsider the vote whereby the rules were suspended and said bill was passed was, by unanimous consent, laid on the table.

Ordered, That the Clerk request the concurrence of the Senate in said bill.

¶67.8 TRAUMA CARE REAUTHORIZATION

Mr. WAXMAN moved to suspend the rules and pass the bill (H.R. 2205) to amend the Public Health Service Act to revise and extend programs relating to trauma care.

The SPEAKER pro tempore, Mr. MAZZOLI, recognized Mr. WAXMAN and Mr. MOORHEAD, each for 20 minutes.

After debate,

The question being put, *viva voce*,

Will the House suspend the rules and pass said bill?

The SPEAKER pro tempore, Mr. MAZZOLI, announced that two-thirds of the Members present had voted in the affirmative.

So, two-thirds of the Members present having voted in favor thereof, the rules were suspended and said bill was passed.

A motion to reconsider the vote whereby the rules were suspended and said bill was passed was, by unanimous consent, laid on the table.

¶67.9 PROVIDING FOR THE CONSIDERATION OF H.R. 2200

Mr. HALL of Ohio, by direction of the Committee on Rules, called up the following resolution (H. Res. 193):

Resolved, That at any time after the adoption of this resolution the Speaker may, pursuant to clause 1(b) of rule XXIII, declare the House resolved into the Committee of the

Whole House on the state of the Union for consideration of the bill (H.R. 2200) to authorize appropriations to the National Aeronautics and Space Administration for research and development, space flight, control, and data communications, construction of facilities, research and program management, and Inspector General, and for other purposes. The first reading of the bill shall be dispensed with. Points of order against consideration of the bill for failure to comply with clause 2(1)(6) of rule XI are waived. General debate shall be confined to the bill and shall not exceed one hour equally divided and controlled by the chairman and ranking minority member of the Committee on Science, Space, and Technology. After general debate the bill shall be considered for amendment under the five-minute rule. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Science, Space, and Technology now printed in the bill. The committee amendment in the nature of a substitute shall be considered by title rather than by section. Each title shall be considered as read. At the conclusion of consideration of the bill for amendment the Committee shall rise and report the bill to the House with such amendments as may have been adopted. Any Member may demand a separate vote in the House on any amendment adopted in the Committee of the Whole to the bill or to the committee amendment in the nature of a substitute. The previous question shall be considered as ordered on the bill and amendments thereto to final passage without intervening motion except one motion to recommend with or without instructions.

When said resolution was considered. After debate,

On motion of Mr. HALL of Ohio, the previous question was ordered on the resolution to its adoption or rejection and under the operation thereof, the resolution was agreed to.

A motion to reconsider the vote whereby said resolution was agreed to was, by unanimous consent, laid on the table.

¶67.10 NASA AUTHORIZATION

The SPEAKER pro tempore, Mr. MAZZOLI, pursuant to House Resolution 193 and rule XXIII, declared the House resolved into the Committee of the Whole House on the state of the Union for the consideration of the bill (H.R. 2200) to authorize appropriations to the National Aeronautics and Space Administration for research and development, space flight, control, and data communications, construction of facilities, research and program management, and Inspector General, and for other purposes.

The SPEAKER pro tempore, Mr. MAZZOLI, by unanimous consent, designated Mrs. UNSOELD as Chairman of the Committee of the Whole; and after some time spent therein,

The SPEAKER pro tempore, Mr. GONZALEZ, assumed the Chair.

When Mrs. UNSOELD, Chairman, reported that the Committee, having had under consideration said bill, had come to no resolution thereon.

¶67.11 H.R. 2201—UNFINISHED BUSINESS

The SPEAKER pro tempore, Mr. GONZALEZ, pursuant to clause 5, rule

I, announced the unfinished business to be the motion to suspend the rules and pass the bill (H.R. 2201) to amend the Public Health Service Act to revise and extend programs relating to the prevention and control of injuries.
