185.3 CHINA M-F-N DISAPPROVAL

On motion of Mr. ROSTENKOWSKI, pursuant to the order of the House of July 15, 1993, the Committee of the Whole House on the state of the Union was discharged from further consideration of the joint resolution (H.J. Res. 208) disapproving the extension of non-discriminatory treatment (most-favored-nation treatment) to the products of the People's Republic of China.

When said joint resolution was considered and read twice.

On motion of Mr. SOLOMON, by unanimous consent,

Ordered, That the time for general debate be increased by ten minutes to be equally divided and controlled by Mr. Rostenkowski and Mr. Solomon.

After debate,

Pursuant to the order of the House of July 15, 1993 and sections 152 and 153 of the Trade Act of 1974, the previous question was ordered.

The joint resolution was ordered to be engrossed and read a third time, was read a third time by title.
