Ordered, That, during further consideration in the Committee of the Whole House on the state of the Union of the bill (H.R. 4276) making appropriations for the Departments of Commerce, Justice, and State, the Judiciary, and related agencies for the fiscal year ending September 30, 1999, and for other purposes, pursuant to House Resolution 508, no amendment shall be in order thereto except for the following amendments, which shall be considered as read, shall not be subject to amendment or to a demand for division of the question in the House or in the Committee of the Whole House on the state of the Union, and shall be debatable for the time specified, equally divided and controlled by a proponent and a Member opposed thereto: An amendment by Mr. Saxton on a limitation regarding foreign assets litigation to be debatable for ten minutes; the amendment numbered 23 by Mr. Holden to be debatable for five minutes; the amendment numbered 35 by Mr. Stearns to be debatable for five minutes; either the amendment numbered 50 or an amendment regarding the Standing Consultative Committee by Mr. McIntosh to be debatable for twenty minutes; the amendment by Mr. Kucinich to be debatable under the five-minute rule; and

that the managers of the bill may make pro forma amendments to strike the last word for the purpose of engaging in colloquies.
