PER CURIAM:

Steven Louis Barnes appeals the district court's orders dismissing his 42 U.S.C. § 1983 (2006) complaint without prejudice and denying reconsideration.* We have reviewed the record and find no reversible error. Accordingly, we affirm for the reasons stated by the district court. Barnes v. Keesley, 4:11-cv-02969-MBS (D.S.C. June 27 & July 25, 2012). We dispense with oral argument because the facts and legal contentions are adequately presented in the materials before the court and argument would not aid the decisional process.
