17 On October 17, 2005, the United States of America, by and
18 through counsel Robin R. Taylor, and defendant SHANEIL MANNING, aka
19 Kim Reed, by and through counsel Caro Marks, appeared before the
20 Hon. Peter A. Nowinski for a Rule 20 hearing or entry of plea in
21 connection with a Criminal Complaint filed in the Eastern District
22 of Virginia on September 27, 2005 alleging violations of Title 18
23 United States Code, Sections 1349, 1343, and 2. (Case No. 05-mj-
24 0202).

25 At the hearing, AFD Marks advised that the defendant would not
26 be entering a guilty plea, and requested that the defendant's case
27 be transferred to the U.S. District Court in the Eastern District of
28 Virginia.

1 The Court ordered the United States to contact the United
2 States Attorney's Office for the Eastern District of Virginia to
3 obtain a court date for defendant MANNING. The Court indicated that
4 once a date was identified, the defendant would be ordered to appear
5 at that time.

6 On November 3, 2005, Assistant U.S. Attorney, Howard Zlotnick,
7 the prosecutor in the Eastern District of Virginia, advised that the
8 matter would be on calendar on November 15, 2005 for initial
9 appearance on the criminal complaint.

10 Thus, the parties respectfully ask the Court to order defendant
11 MANNING to appear on this date.
