2	2. Plaintiff's requests for leave to proceed in forma pauperis (ECF Nos. 2, 6) are granted;		
3	3. Service is appropriate for the following defendants: San Joaquin County, the City of		
4	Manteca, the San Joaquin District Attorney's Office, Jim Buzo, Tim Doe, and John Brinton		
5	4. The Clerk of the Court is directed to issue forthwith, and the U.S. Marshal is directed		
6	to serve within ninety days of the date of this order, all process pursuant to Federal Rule of Civil		
7	Procedure 4, including a copy of this court's status order, without prepayment of costs.
