29 THIS MATTER having come before the Court upon Plaintiff, Chanel, Inc.'s Motion for
30 Final Default Judgment against Defendant Bo Ling, and the Court having considered the moving
31 papers and there being no opposition thereto;

32 IT IS HEREBY ORDERED that Plaintiff's Motion for Final Default Judgment is
33 GRANTED, and judgment is entered in favor of Plaintiff, Chanel, Inc., a New York corporation,
34 with its principal place of business in the United States located at Nine West 57th Street, New York,
35 New York 10019, and against Defendant Bo Ling;

1 IT IS FURTHER ORDERED AND ADJUDGED

2 1. Pursuant to 15 U.S.C. § 1117(c) Plaintiff is awarded statutory damages against
3 Defendant in the amount of Four Hundred and Twenty Thousand Dollars and Zero Cents
4 (\$420,000.00), for which let execution issue;

5 2. Pursuant to 15 U.S.C. § 1117(d) Plaintiff is awarded statutory damages against
6 Defendant in the amount of One Hundred and Fifty Thousand Dollars and Zero Cents (\$150,000.00),
7 for which let execution issue;

8 3. Plaintiff is awarded costs against Defendant in the amount of Six Hundred and Fifty
9 Dollars and Zero Cents (\$650.00), for which let execution issue;


10 4. Prejudgment interest from the date this action was served shall accrue at the legal
11 rate;

12 5. In order to give practical effect to the Permanent Injunction, the domain names
13 identified on the attached Schedule "A" (collectively the "Subject Domain Names") are hereby
14 ordered to be immediately transferred by Defendant, his assignees and/or successors in interest or
15 title, and the Registrars to Plaintiff's control. To the extent the current Registrars do not facilitate
16 the transfer of the Subject Domain Names to Plaintiff's control within ten (10) days of receipt of this
17 judgment, the United States based Registry shall, within thirty (30) days, transfer the Subject
18 Domain Names to a United States based Registrar of Plaintiff's choosing, and that Registrar shall
19 transfer the Subject Domain Names to Plaintiff; and

20 6. Upon Plaintiff's request, the top level domain (TLD) Registries for the Subject
21 Domain Names, within thirty (30) days of receipt of this Order, shall place the Subject Domain
22 Names on Registry Hold status, thus removing them from the TLD zone files maintained by the
23 Registry which link the Subject Domain Name to the IP address where the associated website is
24 hosted.
